NOW, THEREFORE, the parties, notwithstanding anything contained to the contrary in the Note or Mortgage agree as follows:

- THE PRINCIPAL BALANCE REMAINING OF \$24,458.10 PLUS INTEREST ON THE BALANCE OF PRINCIPAL REMAINING BE PAYABLE FROM TIME TO TIME AT THE RATE OF 6.40 PER ANNUM AS FOLLOWS: PRINCIPAL AND INTEREST PAYMENTS OF \$152.51 MONTHLY BEGINNING JUNE 1, 1993 AND MONTHLY TYPEREAFTER UNTIL THE FINAL PAYMENT ON MAY 1, 1998.
 - A) EXTEND THE TERM BY 5 YEARS FROM DATE OF MODIFICATION.
 - B) LOWER RATE TO 6.400%.
