### PARCEL 1

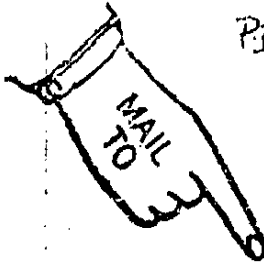
