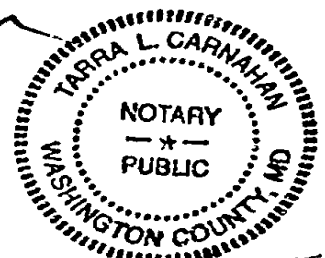

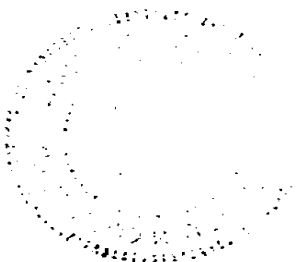

TAKEN AS TRACT
