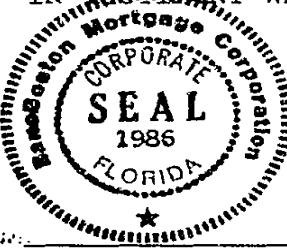
RELEASE OF MORTGAGE BY CORPORATION

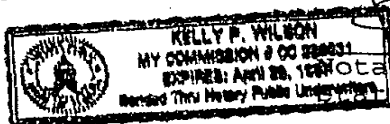
