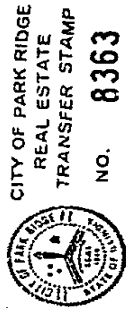

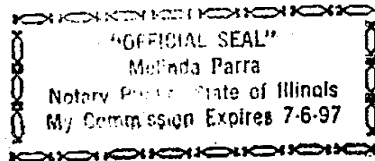

LEGAL DESCRIPTION:
