IT IS HEREBY AGREED, by and between SUBURBAN TRUST AND SAVINGS BANK, the legal holder and owner of that certain note dated April 8, 1988 and secured by a Mortgage of even date, recorded as Document Number 88158656 in the Office of the Recorder of Deeds in Cook County, and the makers, FREDERICK E. GEORGE and JACQUELINE L. GEORGE, his wife, that:

1. The maturity of the aforementioned Note and the Mortgage be extended for an additional 5 years to April 20, 1998;
2. The interest rate be decreased to 9.0 per annum beginning April 21, 1993;
3. The monthly payment of principal and interest be changed to \$208.92 beginning with the May 20, 1993 payment;
4. The balloon payment due on April 20, 1998 will be approximately \$10,273.30 consisting of the 60th regular payment of \$208.92 and the unpaid principal balance of \$10,064.38;
5. The refinancing of the balloon payment may be considered at that time;
6. The monthly payment of \$208.92 will be automatically deducted from Checking Account Number 737-422 beginning with the May 20, 1993 payment.

Except as hereby changed, all rights, duties and obligations and covenants contained in said Note and Mortgage shall remain the same.
