STATUTORY SHORT FORM POWER OF ATTORNEY FOR PROPERTY LAW

Section 3-4. Explanation of powers granted in the statutory short form power of attorney for property and the effect of granting powers defines each category of powers istud in the statutory short form power of attorney for property and the effect of granting powers as agent. When the title of any of the following categories is retained (not struck out) in a statutory property power form, the effect will be to grant the agent all of the principal's rights, powers and discretions with respect to the types of property and the effect will be to grant the agent will not he principal's rights, powers and discretions with respect to the types of the transactions covered by the retained category, subject to any limitations on the granted powers that appear on the lace of the transactions covered by the retained category, subject to any limitations on the granted power at the time of exercise, whether form.
