

This mortgage secures the performance of a certain promissory note of Mortgagee dated this date in the principal amount of \$194,000 payable in equal monthly installments of \$24.00 beginning on 08/07/75 and every month thereafter until the loan is repaid (the said note, together with any future note made payable to mortgagee by assignment).

Mortgagee agrees to pay the said note (which is unsecured by retention) according to its terms and to keep all improvements on said premises in good repair and insured during the term of the Mortgage for maximum insurable value, or such lesser sum as Mortgagee may authorize in writing with Mortgagee named as loss payee as its interest appears.

Mortgagee also agrees to pay any governmental or other levy levied hereafter which would create a lien superior to the lien of Mortgagee hereunder.

Mortgagee may collect costs and disbursements, including reasonable attorney's fees, incurred in legal proceedings to collect on the said note or to enforce or secure this debt.

In the event of default in the payment of the said note, Mortgagee may, (if provided in the note), at its option, declare the entire sum remaining unpaid at once due and payable, and Mortgagee may proceed to foreclose on and sell the above property as provided by law and in connection with any foreclosure proceedings Mortgagee shall be entitled to the immediate appointment of a receiver to take possession and control of the premises, and collect and apply the rents and profits thereof for mortgagee (subject to direction of court) from the time of appointment to the time when the period of redemption expires.
