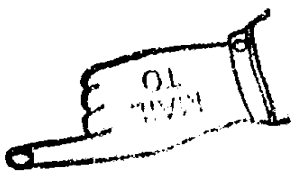

SATISFACTION OF MORTGAGE

KNOW ALL MEN BY THESE PRESENTS: The Director of the Office of Thrift Supervision issued Order number(s) 89-376 dated November 8, 1989, placing Crest Savings in receivership and appointing the Resolution Trust Corporation as Receiver of Crest Savings pursuant to subdivision (F) of Section 5(d) of the Home Owners' Loan Act, as amended.

The Director of the Office of Thrift Supervision, by Order number(s) 89-377 and 89-378 dated November 8, 1989, incorporated a new federal savings association, Crest Federal Savings and Loan Association, and issued its charter appointing the Resolution Trust Corporation as Conservator for Crest Federal Savings and Loan Association, to have "all the powers of a conservator or receiver, as appropriate, granted under the Federal Deposit Insurance Act."

Certain assets of Crest Savings, including the asset which is the subject of this document, have been transferred from Crest Savings to Crest Federal Savings and Loan Association; and, for the purposes of confirming said transfer, Crest Savings does hereby grant, sell, assign, transfer, set over and convey to Crest Federal Savings and Loan Association, its successors and assigns, without recourse or warranty, any interest Crest Savings may have in the security document which is the subject of this document, together with the note, debt and claim secured by such security document and the covenants contained in such security document.

The Director of the Office of Thrift Supervision issued Order number(s) 90-1688 dated September 13, 1990, placing Crest Federal Savings and Loan Association in receivership and replacing the Conservator of Crest Federal Savings and Loan Association with the Resolution Trust Corporation as Receiver of Crest Federal Savings and Loan Association pursuant to subdivision (F) of Section 5(d) of the Home Owners' Loan Act, as amended.

RESOLUTION TRUST CORPORATION, in its capacity as Receiver of Crest Federal Savings and Loan Association having a mailing address of 4900 Main St. Kansas City, MO 64110 is the owner and holder of a certain Mortgage dated October 3, 1989 executed by MICHAEL PETRICK and LILLIAN M. PETRICK, his wife, as Mortgagor, in favor of Crest Savings, as Mortgagee, recorded under Document Number 89486158 of the Public Records of Cook County, IL, covering the property described in Exhibit "A" attached hereto, securing a certain Promissory Note in the principal amount of Thirty thousand six hundred and NO/100 Dollars, and certain promises and obligations set forth in said Mortgage, hereby acknowledges full payment and satisfaction of said Note and Mortgage and surrenders the same as canceled; and hereby empowers, authorizes and directs the County Recorder to cancel the same of record.



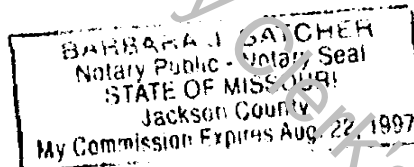
