#### DECLARATION OF TERMINATION OF GROUND LEASE AND MERGER

THIS DECLARATION OF TERMINATION OF GROUND LEASE AND MERGER (this "leclaration") is made and entered as of the 25 day of \_\_\_, 1994 by AMERICAN NATIONAL BANK AND TRUST COMPANY OF CHICAGO, as Trustee under Trust Agreement dated March 23, 1994, and known as Trust Number 118105-04 ("Declarant").

WHEREAS, Declarant acquired the fee interest to a certain parcel of real detate legally described in Exhibit A attached hereto and made a part hereof (the "Fee Estate"); and

WHEREAS, Declarant is also the assignee under that certain Assignment of Lessee's Interest In Ground Lease and Conveyance of Improvements, with Assumption of Ground Lease And Limited Warranty of Title dated May 4, 1994 (the "Assignment") recorded with the Cook County Recorder of Deeds on May 6, 1994 as Document 94412587 pursuant to which Aetna Life Insurance Company assigned to Declarant, and Declarant accepted that certain leasehold estate described in Exhibit B attached herece and made a part hereof (the "Leasehold Estate"); and

WHEREAS, Declarant owns both the Fee Estate and the Leasehold Estate, and Declarant desires to terminate the Leasehold Estate and merge the Leasehold Estate into the Fee Estate:

NOW, THEREFORE, Declarant hereby declares as follows:

- The Leasehold Estate acquired by Declarant under the Assignment is hereby merged into the Fee Estate, and is mull, void and of no further force or effect.
- The terms and provisions of this Declaration shall run with the Fee Estate, and be binding upon Declarant's successors and assigns.
- This Declaration is executed by American National Bank and Trust Company of Chicago ("Bank"), as Trustee as aforesaid, in the exercise of the power and authority conferred upon and vested in it as such Trustee. It is expressly understood and agreed by every person, firm or corporation hereafter claiming any interest under this Declaration that Bank, as Trustee as aforesaid, and not personally, has joined in the execution of this Declaration for the sole purpose of subjecting the title holding interest and the trust estate under said Trust No. 118105-04 to the

terms of this Declaration and that any and all obligations, duties, covenants, indemnities and agreements of every nature herein set forth by Bank, as Trustee as aforesaid, to be kept or performed, are intended to be kept, performed, and discharged by the beneficiaries under said Trust No. 118105-04 or their successors, and not by Bank personally.
