POWER OF ATTORNEY

THE STATE OF ILLINOIS
COUNTY OF Cook

KNOW ALL MEN BY THESE PRESENTS, that I, Yousra Shiehali, have made, constituted and appointed and by these presents do make, constitute, and appoint Felicita Shiehali to be my true and lawful attorney for me and in my name, place and stead, to have the power of sale purchase, acquisition, mortgage, management, disposition and/or control of all my interests in and to the following described property:

My said attorney shall further have the authority to purchase acquire, contract to purchase and sell, to sell and convey said property to any creature whatsoever for such sum, on such terms and with such arrangements as to him shall seem proper to make, execute, acknowledge and deliver good and sufficient conveyances for the same upon any such occasion and with any such covenants, warranties and agreements to be chosen and made as my said attorney shall think fit and convenient; to make, execute, deliver and acknowledge such mortgages, deeds of trust, assignments, contracts, construction loans, agreements, interim financing agreements, long term financing agreements, and other forms of securities and/or otherwise as my attorney shall deem necessary to secure debts, liens, or other obligations with reference thereto and to evidence the same by the execution of such promissory note or notes or other written evidence thereof at my attorney's shall deem necessary until the same shall be paid, to demise or lease said property to such person or persons and for such rent as he may see fit and to sue, demand recover, collect and receive all sums of money which shall become due and owing to me by reason of any such sale, conveyance or lease and to take all lawful ways and means for the recovery thereof, to compound and satisfy the same and to execute and deliver sufficient securities, releases and discharges therefrom as well as of any item or items comprising any obligation arising in connection therewith. My attorney is also granted full authority my said attorney to alter, modify or change any loan documentation, terms or provisions with respect to the loan and mortgage made by William H. Britigan to Yousra Shiehali unless such change shall be with express written consent of said mortgagee. I hereby agree and represent to those persons dealing with my agent and attorney-in-fact that this power of attorney shall not terminate on disability of the principal and may be voluntarily revoked only by a written instrument of revocation filed for record in the office of the County Clerk of Cook County, STATE OF ILLINOIS

except that, if this power of attorney has not been sooner revoked, it shall, in any event, be automatically revoked and terminated and shall become null and void without any further action at 11:59 P.M., on the 10 MAY 1994 day of 1994.
