RELEASE OF MORTGAGE

WHEREAS, ON JULY 10, 1992, TRANSOHIO SAVINGS BANK WAS CLOSED BY THE OFFICE OF THRIFT SUPERVISION, ("OTS") PURSUANT TO SECTION 5 (D) (2) (A) OF THE HOME OWNERS LOAN ACT OF 1933 ("HOLA") AS AMENDED BY SECTION 301 OF THE FINANCIAL INSTITUTIONS REFORM, RECOVERY AND ENFORCEMENT ACT OF 1989 ("FIRREA"), OTS PURSUANT TO ORDER NUMBER 92-307 APPOINTED THE RESOLUTION TRUST CORPORATION ("RTC") AS RECEIVER OF TRANSOHIO SAVINGS BANK.

WHEREAS, ON JULY 10, 1992, THE OTS BY ORDER NUMBER 92-307 CHARTERED TRANSOHIO FEDERAL SAVINGS BANK, AS A FEDERAL MUTUAL SAVINGS BANK, AND CONSERVATOR FOR TRANSOHIO FEDERAL SAVINGS BANK.

WHEREAS, ON JULY 10, 1992, THE RTC AS RECEIVER OF TRANSOHIO SAVINGS BANK AND THE RTC AS CONSERVATOR FOR TRANSOHIO FEDERAL SAVINGS BANK ENTERED INTO A PURCHASE AND ASSUMPTION AGREEMENT WHEREBY THE RTC AS CONSERVATOR FOR TRANSOHIO SAVINGS BANK PURCHASED SUBSTANTIALLY ALL THE ASSETS, DEPOSITS AND SECURED LIABILITIES OF RTC AS RECEIVER OF TRANSOHIO SAVINGS BANK.

WHEREAS, AS A RESULT OF THE TRANSFER FROM THE RTC AS RECEIVER OF TRANSOHIO SAVINGS BANK TO THE RTC AS CONSERVATOR FOR TRANSOHIO FEDERAL SAVINGS BANK, RTC AS CONSERVATOR FOR TRANSOHIO FEDERAL SAVINGS BANK HAVING A MAILING ADDRESS OF 1250 SUPERIOR AVENUE, CLEVELAND, OH 44114 IS THE OWNER AND HOLDER OF THE BELOW MENTIONED NOTE AND MORTGAGE.
