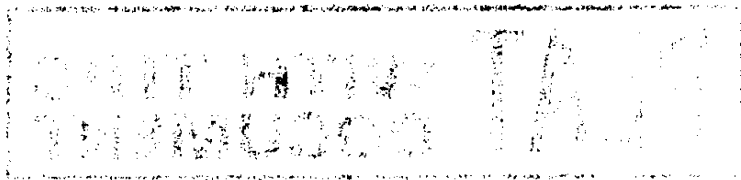

AN ORDINANCE

1994-16

**ANNEXING PROPERTY GENERALLY LOCATED AT THE
SOUTHWEST CORNER OF GOLF ROAD AND GREENWOOD AVENUE**

WHEREAS, a written petition under oath signed by all of the owners of record and a majority of the electors of the land hereinafter described has been filed with the Village Clerk of the Village of Niles, requesting that said land be annexed to the Village of Niles; and

WHEREAS, the said owners of and electors residing upon said property to be annexed have affixed their signatures to said petition indicating their consent; and

WHEREAS, the said land is not within the corporate limits of any municipality, but is contiguous to the corporate limits of the Village of Niles; and

WHEREAS, the President and Board of Trustees of the Village of Niles find and believe it to be in the best interests of the said Village of Niles that said land and territory be annexed thereto; and

WHEREAS, proper notice has been filed with other governmental agencies, as required by law.

NOW THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF NILES, COOK COUNTY, ILLINOIS:

SECTION 1: That all land and territory legally described as follows:

Lots 64 through 71, inclusive, in Golf Greenwood Gardens Subdivision being a Subdivision of the Northwest Quarter of the Northwest Quarter of Section 14, Township 41 North, Range 12, East of the Third Principal Meridian; together with that part of Greenwood Road lying adjacent to and East of the above described property; also that part of Elm Drive lying adjacent to and North of the above described property; also that part of Golf Road, Illinois Route 58, lying North of the above described property, said part of Golf Road being bounded on the West by the Northerly extension of the West line of said Lot 71 and bounded on the East by the Northerly extension of the East right of way line of Greenwood Road (except that part of Greenwood Road lying East of the center line of said Greenwood Road and except that part of Golf Road lying South of the center line of said Golf Road and lying East of the Northerly extension of the center line of said Greenwood Road) all in Cook County, Illinois;

an accurate map of which territory is attached hereto and hereby made a part hereof by this reference be and the same is hereby annexed to the Village of Niles, Cook County, Illinois.

SECTION 4: That this Ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law.


SECTION 5: That all other ordinances or parties of ordinances in conflict with this Ordinance are hereby repealed.




