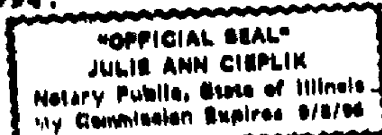

 Example of a strong acid: HCl . Example of a weak acid: CH_3COOH .

Abstract: *Staphylococcus aureus* is a Gram-positive bacterium that is a common cause of skin and soft tissue infections. It is also a leading cause of hospital-acquired infections. The bacterium is known for its ability to form biofilms, which are communities of bacteria that are attached to a surface and encased in a protective matrix. Biofilms are difficult to treat with antibiotics, and they can cause persistent infections. In this study, we investigated the effect of silver nanoparticles (AgNPs) on the growth of *S. aureus* and on its ability to form biofilms. AgNPs were synthesized using a green synthesis method and characterized using UV-Vis spectroscopy, FTIR, and TEM. The AgNPs were then tested against *S. aureus* in a disk diffusion assay and in a biofilm assay. The results showed that AgNPs have a strong antibacterial effect on *S. aureus* and that they inhibit the formation of biofilms. The minimum inhibitory concentration (MIC) of AgNPs against *S. aureus* was determined to be 12.5 µg/ml. The biofilm assay showed that AgNPs at a concentration of 12.5 µg/ml significantly reduced the formation of biofilms. These results suggest that AgNPs may be a promising treatment for *S. aureus* infections, particularly for those involving biofilms.
