EXHIBIT A - LEGAL DESCRIPTION

PARCEL I:

UNIT 2-5-R-11 IN PRINCETON CLUB TOWNE VILLAS CONDOMINIUM, AS DELINEATED ON A SURVEY OF THE FOLLOWING DESCRIBED REAL ESTATE:
