4. On January 20, 1994, the Owner owned the following described land in the County of Cook State of Illinois, to wit:


Unit 46-1J in LaGrange Court Condominium, as delineated on the survey of the following described real estate (hereinafter referred to as parcel): Lots 6, 7, and 8 (except the West 5 feet of said lots condemned for alley) in Block 2 in Leiter's Addition to LaGrange in the Northeast 1/4 of Section 4, Township 38 North, Range 12 East of the Third Principal Meridian, in Cook County, Illinois, as amended by document recorded on January 14, 1994, as document number 94-050663, which survey is attached to the First Amendment to Declaration of Condominium and of Easements, Restrictions and Covenants recorded in the Office of the Recorder of Deeds of Cook County, Illinois, on January 14, 1994, as document number 94-050663, as Exhibit D, together with their respective percentage interests in the common elements.

On or about January 20, 1994, through April 13, 1994, the claimant made a various oral contracts (the "Contract") with Construction Management Group, 1212 North Seminary, Woodstock, Illinois (the "Contractor") a firm whom the owners authorized or knowingly permitted to contract to improve the land, for millwork.

6. The total amount of billings under and pursuant to the Contract was \$1,212,32. The Contractors are entitled to credits for payments made in the amount of \$0.00, leaving due a principal balance of \$1,212,32 for which, the claimant claims a lien on the Land and all improvements on the Land.
