ORDER

This cause coming on to be heard on the set call, the court being fully advised of the premises, and having heard evidence and testimony, the court finds as follows:

- 1) That the subject premises is a four unit building with an illegally converted basement apartment.
- 2) That the illegally converted basement apartment at the subject premises has been removed and de-converted, stove and refrigerator removed, gas and water pipes capped.
- 3) That the basement at the subject premises can be used for storage only, and not as a separate apartment, or for living or sleeping quarters, or for cooking of any kind.
- 4) That no finding is made as to zoning compliance.
- 5) That there is full compliance in this cause.

IT IS HEREBY ORDERED as follows:

1. That a Permanent Injunction issue against Defendants Borko Puljic and Olga Puljic, their agents, successors, and assigns not to rent, lease, use or occupy the subject premises with a separate basement apartment, and that the basement at the subject premises can be used for storage only.

2. The court reserves jurisdiction of this cause for the purpose of enforcement, termination or modification of the above Permanent Injunction.
