#### ADJUSTABLE RATE RIDER

THIS ADJUSTABLE RATE RIDER is made this twenty eighth day of May, 1994, and is incorporated into and shall be deemed to amend and supplement the Mortgage, Deed of Trust or Security Deed ("Security Instrument"), of the same date given by the undersigned ("Borrower") to secure Borrower's Note ("Note") to

THE NOTE CONTAINS PROVISIONS ALLOWINGFOR CHANGES IN THE INTEREST RATE AND THE MONTHLY PAYMENT. THE NOTE LIMITS THE AMOUNT THE BORROWER'S INTEREST RATE CAN CHANGE AT ANY ONE TIME AND THE MAXIMUM RATE THE BORROWER MUST PAY.

ADDITIONAL COVENANTS. In addition to the covenants and agreements made in the Security Instrument, Borrower and Londor further covenant and agree as follows:

#### INTEREST RATE AND MONTALY PAYMENT CHANGES

(A) Chauge Date

The interest rate may change on the first day of October, 1995, and on that day of each succeeding year. "Change Date" means each date on which the interest rate could change.

(D) Limits on Interest Rate Charges

The interest rate will never increase or decrease by more than one percentage point (1.0%) on any single Change Date. The interest rate will never be more than five percentage points (5.0%) higher or lower than the initial interest rate stated in Paragraph 2 of this Note.

(E) Calculation of Payment Change

If the interest rate changes on a Change Date, Lender will calculate the amount of country payment of principal and interest which would be necessary to repay the unpaid principal balance in full at the mate my date at the new interest rate through substantially equal payments.
