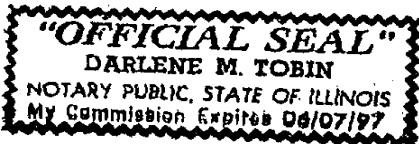

EXHIBIT A

LEGAL DESCRIPTION
