

Declarant desires to amend the said Resubdivision Plat.

NOW, THEREFORE, for and in consideration of the covenants herein contained, Declarant does hereby amend the said Resubdivision Plat so as to show and describe Lot 3 thereon as set forth on Exhibit A attached hereto and made a part hereof.
