WHEREAS, the Honorable Donna Lee H. Williams, the Insurance Commissioner of the State of Delaware (the "Commissioner"), has applied for a Rehabilitation and Injunction Order pursuant to Title 18 Del. C. § 5901, et seq., and

WHEREAS, the Board of Directors of National Heritage Life Insurance Company ("National Heritage" or the "Company") has unanimously consented to the issuance of this Order under Title 18 Del. C. § 5905(9), NOW

IT IS HEREBY ORDERED BY THE COURT as follows:

1. Pursuant to Title 18 Del. C. § 5910(a), the Commissioner shall forthwith conduct the business of National Heritage pursuant to the terms of this Order and take exclusive possession and control of and be vested with all right, title and

The filling or recording of this Order or a certified copy hereof with the Clerk of this Court and with the recorder of deeds of the jurisdiction in which National Heritage's corporate and administration offices are located, or, in the case of real estate, with the recorder of deeds of the jurisdictions where the property is located, shall impart the same notice as would be imparted by a deed, bill of sale or other evidence of title duly filed or recorded with that recorder of deeds. approval of the Commissioner, shall be entitled to exercise all of the powers and authorities vested in the Commissioner pursuant to this Order and applicable law.

7. The Commissioner may employ or continue to employ and fix the compensation of such deputies, counsel, clerks, employees, accountants, actuaries, consultants, assistants and other personnel (collectively, the "Designees") as considered necessary, and all compensation and expenses of the Special Deputy Commissioners and the Designees and of taking possession of National Heritage and conducting this proceeding shall be paid out of the funds and assets of National Heritage as administrative expenses under Title 18 Del. C. § 5913(f). The Commissioner may also retain those of National Heritage's current management personnel and other employees as Designees as she in her discretion determines would facilitate the rehabilitation of National Heritage.

8. The Special Deputy Commissioners, the Designees, and the Board of Directors of National Heritage by reason of their consent to this Order (collectively, the "Indemnitees") shall have no personal liability for their acts or omissions in connection with their duties or their consent to this Order, as the case may be, provided that such acts or omissions are or were undertaken in good faith and without willful misconduct, gross negligence or criminal intent. All expenses, costs and attorney's fees incurred by the Indemnitees in connection with any lawsuit brought against them in their representative capacities shall be subject to the approval of the Commissioner and shall be exclusively paid out of the funds and assets of National Heritage. The Indemnitees shall not be deemed to be employees of the State of Delaware.

9. The Commissioner's right, title and interest in and to all funds recoverable under treaties and agreements of reinsurance heretofore entered into by the Company as the ceding insurer shall continue, and all reinsurance companies involved with the Company are enjoined and restrained from making any settlements with any claimant or policyholder of National Heritage other than the Commissioner as Receiver. The amounts recoverable by the Commissioner from any reinsurer of National Heritage shall not be reduced as a result of this rehabilitation proceeding or by reason of any partial payment or distribution on a reinsured policy, contract or claim, and each such reinsurer of National Heritage is hereby enjoined and restrained from terminating, cancelling, failing to extend or renew, or reducing or changing coverage under any reinsurance policy or contract with National Heritage, except for non-payment of premium. The Commissioner may terminate or rescind any contract with a reinsurer or reinsurers that is contrary to the best interests of the estate rehabilitation.

10. The Commissioner is hereby authorized to transfer National Heritage's assets and liabilities to a separate affiliate or subsidiary for the overall benefit of National Heritage's creditors, stockholder and policyholders, subject to approval by this Court.

11. The Commissioner may change to her own name, the name of any of National Heritage's accounts, funds or other property or assets held with any bank, savings and loan association or other financial institution, and may withdraw such funds, accounts and other property or assets from such institutions or take any lesser action necessary for the proper conduct of this rehabilitation.

12. The Commissioner is hereby authorized to place a moratorium, in her sole discretion, on surrenders of existing policies. No such moratorium shall be imposed, without further order of this Court, on policies or annuities in payment status.

13. National Heritage and its officers, directors, agents, servants and employees are hereby enjoined and restrained from transacting any business of, or on behalf of, National Heritage, or selling, transferring, destroying, wasting, encumbering or disposing of any of the Assets, without the prior written permission of the Commissioner or until further Order of this Court.

14. All banks, brokerage houses, agents, reinsurers, or other companies or persons, either having in their possession Assets or possible Assets, or having notice of these proceedings or of this Order, are hereby enjoined and restrained from disposing of, selling, wasting, encumbering, transferring or destroying any such Assets or possible Assets. This prohibition includes, without limitation, Assets or possible Assets pertaining to any business transaction between National Heritage and any of said parties. No actions concerning, involving, or relating to such Assets or possible Assets may be taken by any of the aforesaid persons or entities enumerated herein, without the prior written permission of the Commissioner, or until further Order of this Court.

15. All officers, directors, agents, servants and employees of National Heritage, and all other persons and companies having notice of these proceedings or of this Order, are hereby enjoined and restrained from instituting or further prosecuting any action at law or in equity or in other proceedings against National Heritage, the Commissioner as Receiver, or the Special Deputy Commissioners or the Designees in

connection with their duties as such, or from obtaining preferences, judgments, attachments or other like liens or encumbrances, or foreclosing upon or making any levy against National Heritage or the Assets, or exercising any right adverse to the right of National Heritage to or in the Assets, or in any way interfering with the Commissioner, the Special Deputy Commissioners or the Designees either in their possession and control of the Assets or in the discharge of their duties hereunder.

16. (a) All persons and companies are hereby enjoined and restrained from asserting any claim against the Commissioner as Receiver of the Company, or against the Special Deputy Commissioners or the Designees in connection with their duties as such, or against the Assets, except insofar as such claims are brought in the rehabilitation proceedings of National Heritage.

(b) Within a reasonable time after receipt of a claim in the rehabilitation proceedings of National Heritage, the Commissioner shall give notice by mail to any and all persons interested in such claim of the Commissioner's proposed report and recommendation to the Court regarding the allowances or denial (in whole or in part) of such claim.

(c) Within sixty (60) days of the mailing of the proposed report and recommendation, the interested person being given notice of such proposed report and recommendation may file a written objection thereto with the New Castle County Register in Chancery, 1000 King Street, Wilmington, Delaware 19801, and the Commissioner.

(e) No hearing will be held regarding the proposed report and recommendation in the absence of a written objection thereto by a person interested therein.


