AN ORDINANCE ANNEXING CERTAIN TERRITORY TO THE VILLAGE OF MIDLOTHIAN

WHEREAS, there has been filed with the Clerk of the Village of Midlothian the verified Petition of the beneficial owners of the hereinafter described property requesting that said property be annexed to the Village of Midlothian, and

WHEREAS, the President and Board of Trustees of the Village of Widlothian have considered said Petition and the facts therein alleged and have determined:

- 1. That said Petition has been duly signed by the beneficial owners of record of all the hereinafter described property.
- 2. That said territory is contiguous to the Village of Midlothian and constitutes one (1) tract which is not within the corporate limits of any city, village, or incorporated town.
- 3. That the welfare of the Village of Midlothian will be served by annexing said territory. 94635653
- 4. That legal notice regarding the intention of the Village to annex said territory has been sent to Acorn Library District at least ten days before annexation of this property, and there is no fire protection district; and the property does not affect any township highway.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MIDLOTHIAN, COUNTY OF COOK AND STATE OF ILLINOIS, that:

SECTION 1: That the tract of land legally described as
