

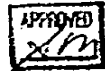

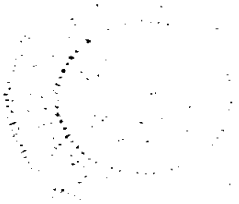

LEGAL DESCRIPTION

Parcel 1:

Lot 28 in Block 8 in Centex Schaumburg Industrial Park Unit 156, being a Subdivision in the East 1/2 of the North West 1/4 of Section 33, Township 41 North, Range 10 East of the Third Principal Meridian, according to the Plat thereof registered July 13, 1979 as Document LR 3104235, in Cook County, Illinois.

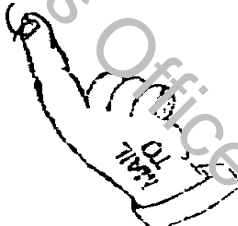
Parcel 2:

That part of the North 30 acres of the East 1/2 of the North West 1/4 of Section 33, Township 41 North, Range 10 East of the Third Principal Meridian, described as follows:

Beginning at the North West Corner of Lot 28 in Block 8 in Centex-Schaumburg Industrial Park Unit No. 156, being a Subdivision in the East 1/2 of the North West 1/4 of Section 33 aforesaid; thence South along the West line of said Lot 28 for a distance of 255.58 feet to a corner of Lot 28 aforesaid (being a point on the Northerly line of Estes Avenue); thence Westerly along said Northerly line of Estes Avenue, being an arc of a circle convex Southwesterly and having a radius of 25.00 feet for a distance of 8.45 Feet to a point of reverse curve; thence Northwesterly along an arc of a circle convex Northeasterly and having a radius of 60.00 feet for a distance of 33.40 feet to a point on a line 32.00 feet (measured at right angles) West of and parallel with the West line of Lot 28 aforesaid; thence North along said parallel line 229.40 feet to the South line of Lot 30 in block 8 in Centex-Schaumburg Industrial Park Unit Number 169, being a Subdivision in the East 1/2 of the North West 1/4 of Section 33 aforesaid; thence East along said South line of Lot 30 for a distance of 32.00 feet to the point of beginning, in Cook County, Illinois.
