

On July 13, 1990, Summit First Federal Savings and Loan Association was closed by the Office of Thrift Supervision ("OTS") pursuant to Section 5 (d) (2) (A) of the Home Owners Loan Act of 1933 ("HOLA") as amended by Section 301 of the Financial Institutions Reform, Recovery and Enforcement Act of 1989 ("FIRREA"). OTS pursuant to order numbers 90-1376 and 90-1377 appointed the Resolution Trust Corporation ("RTC") as Receiver of Summit First Federal Savings and Loan Association.

On July 13, 1990, the OTS by order numbers 90-1378 and 90-1379, chartered Summit First Savings and Loan Association, F.A., as a federal mutual savings bank, and pursuant to Section 5 (d) (2) (B) (1) of HOLA, appointed the RTC as Conservator for Summit First Savings and Loan Association, F.A.

On October 26, 1990, the OTS, by order number 90-1884 and 90-1885, appointed the RTC as the Receiver for Summit First Savings and Loan Association, F.A.

The RESOLUTION TRUST CORPORATION, as Receiver of Summit First Savings and Loan Association, F.A., having a mailing address of 25 Northwest Point Blvd., Elk Grove Village, Illinois, 60007 ("Assignor"), for value received does hereby grant, sell, assign, transfer, set over and convey to Norwest Financial of Il. Inc, having a mailing address of 9632 South Roberts Rd, Hickory Hls, IL, 60457 ("Assignee"), its successors and assigns, without recourse and without any warranties, any interest the Assignor may have in a mortgage ("Mortgage") dated September 7, 1988, from Summit First Savings and Loan Association, F.A. as mortgagor, to Eohania William and Estelle Willis, as mortgagee, given to secure the obligations evidenced by a note given by mortgagor to mortgagee, and recorded October 17, 1988, in Book \_\_\_\_\_ at Page \_\_\_\_\_ as Document No. 88475536, covering the property described as: 1408 W. 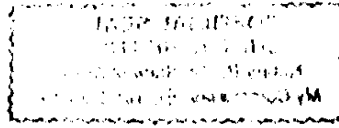
