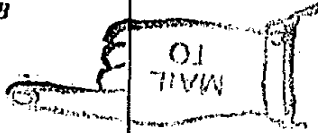

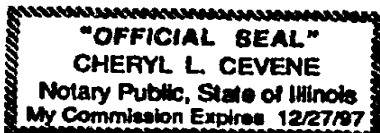

## ATTACHED ADDENDUM FOR LEGAL DESCRIPTION

Parcel 1: UNIT NO.
