

- (b) Sale Without Credit Approval. Lender shall, if permitted by applicable law and with the prior approval of the Secretary, require immediate payment in full of all sums secured by this Security Instrument if:

(i) All or part of the Property, or a beneficial interest in a trust owning all or part of the Property, is sold or

otherwise transfer ed (other than by devise or descent) by the Borrower, and

- 12. Successors and Assigns Bound; Joint and Several Liability; Co-Signers. (E) Calculation of Payment Change
