1. I am the duly appointed Director of Commercial and Housing Code Enforcement of the City of Chicago Heights, a Municipal Corporation of the State of Illinois;

2. That pursuant to Sections 11-22 and 11-26 of the Code of Ordinances of the City of Chicago Heights, determination was made on February 17, 1994 and legally described as:

was in such a state of disrepair to constitute a danger to life and safety of resident of the City of Chicago Heights.

3. On said date I, as Director of Commercial and Housing Code Enforcement, determined that said structure should be demolished as soon as possible.

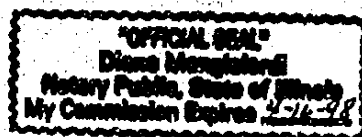
4. That said demolition proceeded and was complete on April 6, 1994.

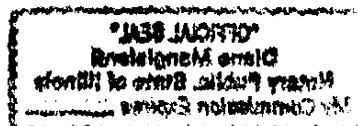

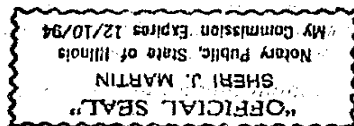
