MORTGAGE LOAN MODIFICATION AGREEMENT

THIS AGREEMENT is entered into on	July 8, 1994	, between

for the purpose of modifying the terms of a NOTE hereinaf	ter more fully described.	Except as herein

Now, therefore, in consideration of this Agreement, and the mutual terms and conditions hereof, and in consideration of the payment by BORROWER of a modification fee of One Thousand Eight and 62/100 Dollars (\$1,008.02), it is hereby agreed as follows:

- 1. The NOTE referred to in this Agreement is that Promissory Note dated March 25, 1991, given by Edward J. Malek, Jr., aivorced not since remarried, to Equity Mortgage Corporation, now known as, or the interest of which has been acquired by, LENDER, in the original amount of One Hundred Thirteen Thousand Two Hundred Fifty and 00/100 Dollars (\$113,250,00), together with interest at the rate of Nine and Three-quarters Percent per annum (9.75%).
- 2. The NOTE is secured by a Mortgage in ed the same date as the NOTE and recorded on April 1, 1991 as Document Number 91-143511 in the office of the County Recorder, County of Cook, State of Illinois, affecting the following described 1 roperty:

LOT 4 IN THE RESUBDIVISION OF LOT 9 , NO THE WEST 1/2 OF LOT 10 IN BLOCK 17 IN BIRCHWOOD BEACH IN FRACTIONAL SECTION 29, TOWNSHIP 41 NORTH, RANGE 14, EAST OF THE THIRD PRINCIPAL MERIDIAN, IN COOK COU'TY, ILLINOIS.

As of June 2, 1994, the unpaid principal balance on the NOTE is One Hundred One Thousand Two Hundred Thirty-nine and 07/100 Dollars (\$101,239.07) which, together with accrued interest and any other amounts due under the NOTE or the Mortgage, if not sooner paid, shall be due on August 1. 2009.
- 4. The NOTE and, to the extent recited therein, the Mortgage are hereby amended as follows:
 - A. The final maturity date is extended to the date set forth in paragraph 3 above.
 - B. The monthly payments of principal and interest, commencing on July 1, 1394 and on the same day of each succeeding month, shall be Nine Hundred Seventy-one and 18/100 T ollars (\$971.18), unless adjusted as provided herein or in the NOTE.
 - C. The interest rate, effective as of June 1, 1994, shall be Eight and One-eighth Percent (8.125%) per annum.
- 5. BORROWER assumes all of the obligations of the original NOTE and Mortgage as modified herein and, except as herein modified, to fully perform all of the covenants and agreements of the original NOTE and Mortgage.
- 6. LENDER'S consent to any modification or assumption as reflected herein shall not obligate LENDER to consent to any further modification or subsequent assumption.


