MEMORANDUM OF LEASE

THIS MEMORANDUM OF LEASE (herein so called) is made and entered into as of this 1st day of August, 1994, by and between LUTHER VILLAGE OWNERS CORPORATION, an Illinois corporation ("Lessor") and LUTHER VILLAGE LIMITED PARTNERSHIP, an Illinois limited partnership ("Lessee").

Recitals:

A. Lessor and Lessee have heretofore entered into that certain proprietary lease dated as of the date hereof ("Lease") with respect to parking space number 1-B (the "Parking Space"), which Parking Space corresponds to a residential unit in a building located on certain land located in Arlington Heights, Illinois, and legally described on Exhibit A attached hereto and by this reference made a part hereof. Any and all defined terms used herein shall have the same meaning as set forth in the Lease, except as otherwise provided herein.

B. Lessor and Lessee have agreed to enter into this Memorandum of Lease for purposes of giving notice of said Lease and certain of its terms, covenants and conditions.

NOW, THEREFORE, in consideration of the covenants hereinafter contained and for other good and valuable consideration and in consideration of the Maintenance and the covenants and conditions more particularly set forth in the Lease, Lessor and Lessee do hereby covenant and agree as follows:

1. Lease of Parking Space. Lessor does hereby demise and lease to Lessee and Lessee hereby leases from Lessor the Parking Space for the Term hereinafter provided, on and subject to the terms and conditions of the Lease.

2. Term. The term of the Lease commences on August 1, 1994 ("Commencement Date") and shall continue until 11:59 p.m. on November 7, 2088, unless sooner terminated or further extended as provided in the Lease.

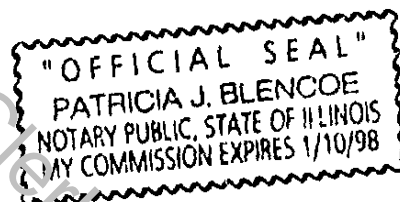
