A part of the Southeast Quarter (SE $\frac{1}{4}$) of the Southwest Quarter (SW $\frac{1}{4}$), Section Twenty-Five (25), Township Twenty-seven (27) North, Range Fifteen (15) West, described as follows:

Commencing at the point where the South line of the said SE $\frac{1}{4}$ of the SW $\frac{1}{4}$ intersects with the center line of C.T.H. "P"; thence North along the centerline of C.T.H. "P" 264 feet; thence at a right angle due East to the East line of the said SE $\frac{1}{4}$ of the SW $\frac{1}{4}$ which is the point of beginning; thence South 225 feet along the East line of the said SE $\frac{1}{4}$ of the SW $\frac{1}{4}$; thence at a right angle West 125 feet; thence at a right angle North 225 feet; thence at a right angle to the point of beginning.

Together with an easement for driveway purposes bounded by the following lines:
