ASSIGNMENT OF RENTS

The interest rate on the Note is 8.500%. The Note is payable in 120 monthly payments of \$991,89

Property. The word "Property" means the real property, and all improvements thereon, described abit in the "Assignment" section.

Real Property. The words "Real Property" mean the property, interests and rights described above in the "property Definition" section.

Related Documents. The words "Related Documents" mean and include without limitation all promissory increases, credit agreements, loan agreements, environmental agreements, guaranties, security agreements, mortgages, deeds of trust, and all other instruments, agreements and documents, whether now or hereafter existing, executed in connection with the indebtedness.

Rents. The word "Rents" means all rents, revenues, income, issues, profits and proceeds from the Property, whethar cue now or later, including without limitation all Rents from all leases described on any exhibit attached to this Assignment.

THIS ASSIGNMENT IS GIVEN TO SECURE (1) PAYMENT OF THE INDEBTEDNESS AND (2) PERFORMANCE OF ANY AND ALL OBLIGATIONS OF GRANTOR UNDER THE NOTE, THIS ASSIGNMENT, AND THE RELATED DOCUMENTS. THIS ASSIGNMENT IS GIVEN AND ACCEPTED ON. THE FOLLOWING TERMS:

PAYMENT AND PERFORMANCE. Except as otherwise provided in this Assignment, Grantor shall pay to Lender all amounts secured by this Assignment as they become due; and shall strictly perform all of Grantor's obligations under this Assignment. Unless and until Lender exercises its right to collect the Rents as provided below and so long seithers is no default under this Assignment, Grantor may remain in possession and control of and operate and manage the Property, and collect the Rents, provided that the granting of the right to collect the Rents shall not constitute Lender's consent to the use of cash collateral in a bankruptcy proceeding.

GRANTOR'S REPRESENTATIONS AND WARRANTIES WITH RESPECT TO THE RENTS. With respect to the Rents, Grantor represents and warrants to Lender that:

Ownership. Grantor is entitled to receive the Rents free and clear of all rights, loans, liens, encumbrances, and claims except as disclosed to and accepted by Lender in writing.

Right to Assign. Granter has the full right, power, and authority to enter into this Assignment and to assign and convey the Rents to Lender.

No Prior Assignment. Grantor has not previously assigned or conveyed the Rents to any other person by any instrument now in force.

No Further Transfer. Grantor will not sell, assign, encumber, or otherwise dispose of any of Grantor's rights in the Rents except as provided in

LENDER'S RIGHT TO COLLECT RENTS. Lender shall have the right at any time, and even though no default shall have occurred under this Assignment, to collect and receive the Rents. For this purpose, Lender is hereby given and granted the following rights, powers and authority:

Notice to Tenants. Lender may send notices to any and all tenants of the Property advising them of this Assignment and directing all Rents to be paid directly to Lender or Lender's agent.

Enter the Property. Lender may enter upon and take possession of the Property; demand, collect and receive from the tenants or from any other persons liable therefor, all of the Rents; institute and carry on all legal proceedings necessary for the protection of the Property, including such proceedings as may be necessary to recover possession of the Property; collect the Rents and remove any tenant or tenants or other persons

Maintain the Property. Lender may enter upon the Property to maintain the Property and keep the same in repair, to pay the costs thereof and of all services of all employees, including their equipment, and of all continuing costs and expenses of maintaining the Property in proper repair and



condition, and also to pay all taxee, assessments and water utilities, and the premiums on fire and other insurance effected by Lender on the Property.

Compilance with Laws. Lender may do any and all things to execute and comply with the laws of the State of Iffinois and also all other laws, rules, orders, ordinances and requirements of all other governmental agencies affecting the Property.

If such a failure is curable and if Glamor has not been given a notice of a breach of the same provision of this Assignment within the preceding twelve (12) months, it may be durer (and no Event of Default will have occurred) if Grantor, after Lender sends written notice demanding cure of such failure: (a) curse the failure within fifteen (15) days; or (b) if the curs requires more than fifteen (15) days, immediately initiates steps sufficient to cure the failure and thereafter or nitrues and completes all reasonable and necessary steps sufficient to produce compilance as soon as reasonably practical.

Insolvency.
