### FINDINGS

1. The Petitioner's Order to Show Cause for Change in Primary Physical Placement and Termination of Family Support Payments was filed on March 29, 1994, and originally scheduled to be heard April 28, 1994.

2. By request of the Respondent, the hearing date was changed from April 28, 1994 to June 9, 1994.

3. Pursuant to the terms of the Judgment of Divorce, the Petitioner was to pay the sum of \$2,708.33 semi-monthly as family support for the Respondent and the parties' two minor children, Sean and Patrick. From March 29, 1994 to June 9, 1994 said sum totals \$12,970.28.

4. From March 27, 1994 to the present date, Patrick Vinck lived with William Vinck.

5. From March 27, 1994 to May 27, 1994, Sean Vinck lived with William Vinck but stayed with his maternal grandmother in Illinois during the school week. On or about May 27 to June 7, 1994, he resided with Mary Vinck. From June 7, 1994 to the present date, he has lived with William Vinck.

## ORDER

1. Based upon the fact that the children were no longer residing with the Respondent and the Petitioner did not have the opportunity to have his motion heard, the Court makes a nunc pro tunc Order suspending Family Support payments from the date of filing of the Petitioner's Motion, March 29, 1994. The Petitioner shall have a judgment against the Respondent for \$12,970.28, the amount of Family Support payments paid from March 29, 1994 through June 9, 1994.

2. Further, based upon the death of the Respondent, all previous Orders with respect to custody and family support are rescinded and the Petitioner shall have sole custody and primary physical placement of Sean and Patrick Vinck. Any funds received by Racine County from the Petitioner to the Respondent shall be returned to the Petitioner forthwith and all wage assignments shall be void.
