Borrower covernants that Borrower is lawfully selzed of the estate heroby conveyed and has the right to mortgage, crant and convey the Property, and that the Property is undecombered, except for proumblances of record. Borrower coverants that Borrower warrants and will defend generally the little to the Property against all claims and demands, subject to encumbrances of record.

UNIFORM COVENANTS. Borrower and Lender covenant and agree as follows:

- Payment of Principal and Interest; Prepayment and Lata Chargus. Borrower shall promptly pay when due the principal of and interest on the debt evidenced by the Note and any prepayment, lete charges and other charges due under the Note.
- Funds for Taxes and Insurance. Benower shall not be obligated to make such payments of Funds to Lender to the extent that Borrower makes such payments to the holder of a prior mortgage or doed of trust it such holder is ab-

If Borrower pays Funds to Lendor, the Funds shall be hold in an institution the deposits or accounts of which are insured or guaranteed by a Federal or state agency (including Lander if Lender is such an Institution). Lander shall apply the Funds to pay said taxes, assessments, insurance premiums and ground routs. Londer may not charge for so holding and applying the Funds, analyzing said account or veiliging and compiling said assessments and bills, unless Lunder pays Borrower interest on the Funds and applicable law permits Lander to make such a charge. Borrower and Lundor may agree in writing at the time of execution of this Mortgage that interest on the Funds shall be paid to Borrower, and unless such agreement is made or applicable law requires such interest to be paid, Lender stratt not be required to pay Borrows any Interest or earnings on this Funds. Lunder shall give to Borrows, without charge, an annual accounting of the Funds showing credits and debits to the Funds and the purpose for which each debit to the Funds was made. The Funds are pledged as additional accurity for the sums secured by this Mortgage.

If the amount of the Funds hold by Lender, together with the future monthly installments of Funds payable prior to the due dates of taxes, assessments, insurance premiums and ground rents, shall exceed the amount required to pay said taxes, assessments, insurance premiums and ground rents as they fall due, such exceed shall be, at Borrower's reption, within promptly repaid to Borrower or credited to Borrower on monthly installments of Funds. If the amount of the Funds hold by Lender shall not be sufficient to pay taxes, assessments, insurance premiums and ground rents as they tall due, Borrower shall pay to Lender any amount necessary to make up the deliciency in one or more payments as Lender may require.

Upon payment in full of all sums secured by this Mortgage, Lender shall promptly refund to Borrower any Funds held by Lender. - 3. Application of Payments. Unless applicable law provides otherwise, all payments received by Lender under the Note and paragraphs 1 and 2 hereof shall be applied by Lender first in payment of amounts payable to Lender by Borrower under paragraph 2 hereof, then to interest payable on the Note, and then to the principal of the Note.
- 4. Prior Mortgages and Deeds of Trust; Charges; Lions. Borrown shall perform all of Borrower's obligations under any mortgage, doed of trust or other security agreement with a flen which has priority over this Mortgage, including Borrower's coverants to make payments when doed for ower shall pay or cause to be paid all taxes, assessments and other charges, tines and impositions attributable to the Property ("Property Taxes") which may attein a priority over this Mortgage, and tenselied payments or ground rents, if any. In the event Borrower lasts to pay any does and payable Property Taxes, Lender may, in its sole discretion, pay such charges and add the amounts thereof to the principal amount of the Posts Secured by the Security Instrument on which interest shall accrue at the contract rate set forth in the Nois.
- 5. Hazard Insurance. Borrower shall keep the improvements now existing or hereafter erected on the Property insured against lose by lire, hazards included within the turm "extended coverage", and such other hazards as Lender may require and in such amounts and for such periods as Lender may require.

The insurance carrier providing the insurance shall be chosen by Borrower subject to approval by Lunder; provided, that such approval shall not be unreasonably withhold. It, the event Borrower table to maintain hazard insurance (including any required flood insurance) in an amount sufficient to satisfy all indebtedness fees, and charges eved Lunder (in addition to payment of all liens and charges which may have priority over Londer's interest in the property. It inder may, in its sole discription, obtain truch insurance naming Lender as the sole beneficiary (single interest coverage). Lender may add any many paid for such insurance to time principal amount of the loan accured by this Security Instrument on which interest shall accure at the contract rate set forth in the Note. All insurance policies and renewals thereof shall be in a form acceptable to Lunder and shall include a run lard mortgage clause in layor of and in a form acceptable to Lunder. Lender shall have the right to hold the policies and renewals thereof, where the terms of any mortgage, deed of trust or other security agreement with a flen which has priority over this Mortgage.

In the event of loss, Borrower shall give prompt notice to the insurance carrier and Lender. Lender may make proof of loss if not made promptly by Borrower.

If the Property is abandoned by Borrower, or if Borrower fails to respond to Lender within 30 days from the date notice is mailed by Londer to Borrower that the insurance carrier offers to settle a claim or neurance benefits, Lender to authorized to collect and apply the insurance proceeds at Lender's option either to restoration or repair of the frequety or to the semis secured by this Mortgage.

- 6. Preservation and Maintenance of Property; Leaseholds; Curuo nintums; Planned Unit Davelopments. Borrows shall keep the Property in good repair and shall not commit waste or permit impairmy it or deterioration of the Property and shall comply with the provisions of any lease if this Mortgage is on a tensohold. If this Mortgage is on a unit in a condominium or a planned unit development, Borrower shall perform all of Borrower's obligations under the declaration or coverants or arriving or governing the condominium or planned unit development, the by-laws and regulations of the condominium or planned unit development, and constituent documents.
- Protection of Lender's Security. If Borrower Inits to perform the coverant's and agreements contained in this Mortgage, or if any action or proceeding is commenced which materially affects Lender's interest in the Property (including without finitiation), then Lender, at Lender's option, upon notice to Borrower, may make such appropriate, disturse such such action as is necessary to protect Lender's Interest. If Lander required mortgage insurance as a condition of making the loan secured by this Mortgage, Borrower shalf per the premiums required to maintain such insurance in effect until such time as the requirement for such insurance terminates in accordance with Borrower's and Lander's written agreement or applicable law.

Any amounts disbuted by Lender pursuant to this paragraph 7, with interest thereon, at the field rate, shall become additional indobtedness of Borrower secured by this Mortgage. Unless Borrower and Lender agree to other terms of payment, such amounts shall be payable upon notice from Lender to Borrower requesting payment mercet. Nothing contained in this paragraph 7 shall require Lender to Incur any expense of take any action belowner.

- Inspection. Lender may make or cause to be made reasonable entries upon and inspections of the Property, provided that Lender shall give Borrower notice prior to any such inspection specifying reasonable cause therefor related to Lender's interest in the Property.
- 9. Condemnation. The proceeds of any award or claim for damages, direct or consequential, in connection with any condemnation or other taking of the Property, or part thereof, or for conveyance in her of condemnation, are hereby assigned and shall be paid to Lander, subject to the terms of any mortgage, doed of trust or other security agreement with a lien which has priority over this Mortgage.
- 10. Borrower Not Released; Forbearance By Lender Not a Walver. Extension of the time for payment or modification of amortization of the sums secured by this Mortgage granted by Lender to any successor in interest of Borrower shall not operate to release, in any manner, the liability of the original Borrower and Borrower's successors in Interest. Lender shall not be required to commence proceedings against such successor or refuse to extend time for payment or otherwise modify amortization of the sums secured by the Mortgage by reason of any demand made by the original Borrower and Borrower's successors in interest. Any forbearance by Lender in exercising any right or remedy hereunder, or otherwise afforded by applicable law, shall not be a warver of or proclude the exercise of any such right or remedy.

- 13. Governing Law; Severability. The state and local laws applicable to this Mortgage shall be the laws of the jurisdiction in which the Property is located. The foregoing sentence shall not limit the applicability of Federal law to this Mortgage. In the event that any provision or clause of this Mortgage or the Note conflicts with applicable law, such conflict shall not affect other provisions of this Mortgage or the Note which can be given effect without the conflicting provision, and to this end the provisions of this Mortgage and the Note are declared to be severable. As used herein, "costs", "expenses" and "attorneys' Mos" include all sums to the extent not prohibited by applicable law or limited herein.
- Borrower's Copy. Borrower shall be furnished a conformed copy of the Note and of this Mortgage at the time of execution or after recordation hereof.
- 15. Rehabilitation Loan Agreement. Borrower shall fulfill all of Borrower's obligations under any home rehabilitation, improvement, repair, or other loan agreement which Borrower enters into with Lender. Lender, at Lender's option, may require Borrower to execute and deliver to Lender, in a form accupitable to Lender, an assignment of any rights, cialms or detenses which Borrower may have against parties who supply labor, materials or services in commodism with improvements made to the Property.
- Transfer of the Property or a Beneficial Interest in Berrovar. If all or any part of the Property or an interest therein is solid or transferred by Berrower (or if a beneficial interest in Berrower is solid or transferred and Berrower is not a natural person or persons but is a corporation, partry 1, hip, trust or other legal entity) without Londer's prior written consent, excluding (a) the creation of a lian or encumbrance subordinate to this peculity instrument which does not relate to a transfer of rights of occupancy in this property, (b) the creation of a purchase money secure interest for household appliances (c) a transfer by devise, descent or by operation of law upon the death of a joint tenant or (d) the gran of any leasehold interest of three years or less not containing an option to purchase, Lender may, at Lender's option, declars all the sums secured by this Security Instrument to be instructed to the and payable.

If Lander exercises such applion to accelerate, Lander shall mall Borrower notice of acceleration in accordance with paragraph 12 hereof. Such notice shall provide a period of not less than 30 days from the date the notice is mailed within which Borrower may pay the sums declared due. To the extent permitted by applicable law, Lender also may charge a reasonable fee as a condition to Lender's consent to any sale or transfer.

- 17. Acceleration; Remedies. If the breach is not cured on or before the date specified in the notice, Lender, at Lender's option, may declare all of the cure's secured by this Mortgage to be immediately due and payable without further demand and may foreclose this Mortgage by It dicat proceeding. Lender shall be entitled to collect in such proceeding all expenses of foreclosure, including, but not limited to, reaschable attorneys' fees and costs of documentary evidence, abstracts and title reports.
- 18. Borrower's Right to Reinstale. Notwithstanding Lander's acceleration of the sums sected by this Mortgage due to Borrower's breach, Borrower shall have the right to have any proceedings begun by Lender to enforce this mortgage, discontinued at any time prior to the entry of a judgment enforcing this Mortgage tt: (a) Borrower pays Lander all sums which would be then due under this Mortgage and the Note had no acceleration occurred; (b) Borrower cures all breaches of any other covenants or experiments of Borrower contained in this Mortgage; (c) Borrower pays all reasonable expenses incurred by Londer in enforcing the covenants and agreements of Borrower contained in this Mortgage, and in enforcing Londer's remodies as provided in paragraph 17 hereof, including, but not limited to, reasonable alterneys' loos; and (d) Borrower takes such action as Londer may reasonably require to assure that the lien of this Mortgage, Londer's interest in the Property and Borrower's obligation to pay the sums secured by this Mortgage shall continue unimpaired. Upon such payment and cure by Borrower, this Mortgage and the obligations secured hereby shall remain in full force and effect as it no acceleration had occurred.
- 19. Assignment of Rents; Appointment of Receiver. As additional accurity herounder, Borrower hereby assigns to Lender the rents of the Property, provided that Borrower shall, prior to acceleration under paragraph 17 heroof or abandonment of the Property, have the right to collect and retain such rents as they become due and payable.

Upon acceleration under paragraph 17 hereof or abandonment of the Property, Lender shall be entitled to have a receiver appointed by a court to enter upon, take possession of and manage the Property and to collect the rants of the Property including those past due. All rants collected by the receiver shall be applied first to payment of the costs of management of the Property and collection of rants, including, but not limited to, receiver's fees, premiums on receiver's bonds and reasonable alterneys' fees, and then to the sums secured by this Mortgage. The receiver shall be liable to account only for those rants actually received.

- 20. Release. Upon payment of all sums secured by this Mortgage, Londor shall release this Mortgage without charge to Borrower. Somewer shall pay all costs of recordation, if any.

ASSIGNMENT OF RENTS

THIS 1-4 FAMILY RIDER is made this 18TH day of APRIL

19 94 ,and is incorporated into and shall be deemed to amend and supplement the Mortage, Deed of Trust or Security Deed (the "Security Instrument") of the same date given by the undersigned (the "Borrower") to secure Borrower's Note to HARBOR FINANCIAL GROUP, LTD. (the "Lender") of the same date and covering the property described in the Security Instrument and located at:

1-4 FAMILY COVENANTS. In addition to the covenants and agreements made in the Security Instrument, Borrower and Lender further covenant and agree as follows:

USE OF PROPERTY: COMPLIANCE WITH LAW. Borrower shall not seek, agree to or make a change in the use of the Property or its zoning classification, unless Lender has agreed in writing to the change. Borrower shall comply with all laws, ordinances, regulations and requirements of any governmental body applicable to the Property.

- B. SUBORDINATE LIENS. Except as prohibited by federal law, Borrower shall not allow any lien inferio. to the Security Instrument to be perfected against the Porperty without Lender's prior written permission.
- C. RENT LOSS INSURALCA. Borrower shall maintain insurance against rent loss in addition to the other hazards for which insurance is required by Security Instrument.
- D. "BORROWER'S RIGHT TO REFISTATE" DELETED UNLESS PROHIBITED BY APPLICABLE LAW. Security Instrument is deleted.
- E. ASSIGNMENT OF LEASE. Upon Lender's request. Borrower shall assign to Lender all leases of the Property and all security deposits made in connection with leases, of the Property. Upon the assignment, Lender shall have the right to modify, extend or terminate the existing leases and to execute new leases. In Lender's sole discretion. As used in this paragraph E. the word "lease" shall mean "sublease" if the Security Instrument is on a leasehold.
- F. ASSIGNMENT OF RENTS. Borrower unconditionally assigns and transfers to Lender all the rents and revenues of the Property. Borrower authorizes Lender or Lender's agents to collect the rents and revenues and hereby directs each tenant of the Property to pay the rents to Lender or Lender's idents. However, prior to Lender's Notice to Borrower of Borrower's breach of inv convenant or agreement in the Security Instrument, Borrower shall collect and receive all rents and revenues of the Property as trustee for the benefit of Lender and Borrower. This assignment of rents constitutes an absolute assignemnt and not an assignment for additional security only.

If Lender gives notice of breach to Borrower: (1) all remis received by Borrower shall be held by Borrower as trustee for benefit of Lender only, to be applied to the sums secured by the Security Instrument: (ii) Lender shall be exhibted to collect and receive all of the remis of the Property; and (iii) each tenant of the Property shall pay all remis due and unpaid to Lender or Lender's agent on Lender's written demand to the tenant

Borrower has not executed any prior assignment of the rents and has not and will not perform any act that would prevent Lender from exercising its rights under this paragraph F.

Lender shall not be required to enter upon, take control of or maintain the Property before or after giving notice of breach to Borrower. However, Lender or a judicially appointed receiver may do so at any time there is a breach. Any application of rents shall not cure or waive any default or invalidate any other right or remedy of Lender. This assignment of rents of the Property shall terminate when the debt secured by the Security Instrument is paid in full.

G. GROSS DEFAULT PROVISION. Borrower's default or breach under any note or agreement in which Lender has an interest shall be a breach under the Security Instrument and Lender may invoke any of the remedies permitted by the Security Instrument.
