[X] Borrower's monthly payment will change annually on each armiversary date of the first payment due date. Lender will determine the amount of the monthly payment that would be large enough to reray the unpuid principal balance of the Note plus interest on that amount in full by the final payment due date. Lender will give to Borrower r notice of any changes in the monthly payment at least 25 days (but no more than [20 days) before the date when the change becomes effective Lender will use the interest rate in effect on the date shown in the notice of payment change (referred to below) to make this calculation. If nv Note has not been paid in full by

SEFTEMBER 13, 2009 Borrower will pay the remaining unperd principal and accrued interest in fall on that date.

Borrower will continue to make regular monthly payments until the unpaid principal and interest due under the Note have been paid in full. Interest rate increases may extend the original payment schedule. If the Note have been paid in full by

Borrower will pay the remaining unpaid principe in a secrued interest in full on that date.

Borrower's final payment will be adjusted so that the unpaid principal and interest due under the Note will be paid in full.

NOTICE.

Lender will give to Borrower a notice at least once each year during which an interest rate adjustment is implemented without an accompanying change in the amount of the monthly payment. The notice will include the current and (n) or interest rates, a statement of the loan balance and other information required by law and useful to Borrower.

ECAN CHARGES.

If the loan secured by the Security Instrument is subject to a law which sets maximum loan charges, and more loss in that the interest or other loan charges collected or to be collected in connection with the loan exceed permitted, the alts, then: (1) any such loan charge shall be reduced by the amount necessary to reduce the charge to the permitted limit; and (2) any sums the ady collected from Borrower which exceeded permitted limits will be refunded to Borrower. Lender may choose to make this refund of the principal owed under the Note or by making a direct payment to Borrower. If a refund reduces principal, the reduction will be treated as a partial prepayment under the Note.

LEGISLATION.

If, after the date hereof, enactment or expiration of applicable laws have the effect either of rendering the provisions of the Note, the Security Instrument or this Variable Rate Rider (other than this paragraph) unenforceable according to their terms, or all or any part of the sums secured hereby uncollectable, as otherwise provided in the Security Instrument and this Variable Rate Rider, or of diminishing the value of Lender's security, then Lender, at Lender's option, may declare all sums secured by the Security Instrument to be immediately due and psyable.
