TOGETHER WITH all ronts, income, issues and profits arising from the Leases and together with all rents, income, issues and profits (including all oil and gas or other mineral royalties and bonuses) from the use, enjoyment and occupancy of the Mortgaged Property (hereinafter collectively referred to as the "Rents").

Assigned to Assignor evidenced by that certain Mortgage Note made by Assignor to Assignee, dated the date hereof, in the principal sum of \$65,000.00 (the "Note") and secured by that certain Mortgage and Security Agreement given by Assignor to Assignee, dated the date hereof, covering the Mortgage and Property and intended to be duly recorded (the "Mortgage"). The principal sum, interest and all other sums due and payable under the Note and Mortgage are collectively referred to as the "Debt". The documents, other than this Assignment, the Note and the Mortgage, now or hereafter executed by Assignor and/or others and by or in favor of Assignee which wholly or partially secure or guarantee payment of the Debt are hereinafter referred to as the "Other Security Documents".

ASSIGNOR WARRANTS (that (a) Assignor is the sole owner of the entire lessor's interest in the Leases; (b) the Leases are valid and enforceable and have not been altered, modified or amended in any manner whatsoever except as the cin set forth; (c) none of the Rents reserved in the Leases have been assigned or otherwise pledged or in petheented; (d) none of the Rents have been collected for more than one (1) month in advance; (e) Assignor has full power and authority to execute and deliver this Agreement and the execution and delivery of this Assignment has been duly authorized and does not conflict with or constitute a default under any law, judicial order or other agreement affecting Assignor or the Mortgaged Property; (f) the improvements to the premises demised under the Leases have been completed and the tenants under the Leases have been completed and the tenants under the Leases have accepted the same and have taken possession of the same on a rent-paying basis; and (g) there exist no office, or defenses to the payment of any portion of the Rents.

ASSIGNOR COVENANTS with Assignee that Assignor (a) shall observe and perform all the obligations imposed upon the lessor under the Leases and shall not do or permit to be done anything to impair the value of the Leases as security for the Debt; (b) shall promptly send expics to Assignee of all notices of default which Assignor shall send or receive thereunder; (c) shall enforce all of the terms, covenants and conditions contained in the Leases and any guaranties thereof upon the part of the lessees and the guaranters thereunder to be observed or performed, short of termination thereof; (d) shall not collect any of the Rents more than one (1) month in advance; (e) shall not execute any other assignment of lessor's interest in the Leases or the Rents; (f) shall not alter, modify or change the terms of the Leases without the prior written consent of Assignee, or cancel or terminate the Leases or accept a surrender thereof or convey or transfer or suffer or permit a conveyance or transfer of the Mortgaged Property or of any interest therein so as to effect a merger of the estates and rights of, or a termination or diminution of the obligations of, lessees thereunder; (g) shall not alter, modify or change the terms of any guaranty of any of the Leases or cancel or terminate any such guaranty without the prior written consent of Assignee; (h) shall not consent to any assignment of or subletting under the Leases not in accordance with its terms, without the prior written consent of Assignee; and (i) shall execute and deliver at the

request of Assignee all such further assurances, confirmations and assignments in connection with the Mortgaged Property as Assignee shall from time to time require.

ASSIGNOR FURTHER COVENANTS with Assignee that (a) all Leases shall be written on the standard form of lease which has been approved by Assignee; (b) upon request, Assignor shall furnish Assignee with executed copies of all Leases; (c) no material changes may be made to the Assignee-approved standard lease without the prior written consent of Assignee; (d) all renewals of Leases and all proposed leases shall provide for rental rates comparable to existing bond market rates and shall be arms-length transactions; (e) all proposed leases shall be subject to the prior approval of the Assignee except that all proposed leases which (i) are on the same form of lease which has been approved by a ssignee, (ii) are the result of an arms-length transaction, (iii) which provide for rental rates comparable to existing market rates, and (iv) do not contain any terms which would materially affect Assignee's rights ander the Mortgage, the Note, the Other Security Documents or this Assignment, shall not be subject to the original provide of Assignee; and (f) all Leases shall provide that they are subordinate to the Mortgage and the the leases angree to attorn to Assignee.

THIS ASSIGNMENT is made on the following terms, covenants and conditions:

- Program Assignment. Assignor does hereby absolutely and 1. unconditionally assign to Assignee Assigner's right, title and interest in all current and future Leases and Rents, it being intended by Assignor that this assignment constitutes a present, absolute assignment and not an assignment for additional security only. Such assignment to Assignee shall not be construed to bind Assignee to the performance of any of the coronints, conditions and provisions contained in any such Lease or otherwise impose any obligation upon Assignee. Assigner agrees to execute and deliver to Assignee such additional instruments, in form and substrace satisfactory to Assignee, as may be confer be requested by Assignee to further evidence and confirm rac assignment. Nevertheless, subject to the terms of this paragraph 1. Assignee grants to Assigner a revocable license to operate and manage the Mortgaged Property and to collect the Rents. Assignor shall hold the Rents, or a portion thereof sufficient to discharge all current sums the on the Dobt, in trust for the benefit of Assignee for use in the payment of such sums. Upon an Event of Default (as defined in the Mo 12140), the fleense granted to Assignor herein shall automatically be revoked, and Assignee shall intracdiately be entitled to possession of all Rents, whether or not Assignee enters upon or takes control of the Mortang of Property. Assignee is hereby granted and assigned by Assignor the right, at its ontion, upon revocation of the license granted herein, to enter upon the Mortgaged Property in person, by agent or by court-appointed receiver to collect the Rents. Any Rents collected after the revocation of the license may be applied toward payment of the Debt in such priority and proportions as Assignee in its discretion shall deem proper.
- Assignee may, at its option, without waiving such Event of Default, without notice and without regard to the adequacy of the security for the Debt, either in person or by agent, with or without bringing any netion or proceeding, or by a receiver appointed by a court, take possession of the Mortgaged Property and have, hold, manage, lease and operate the Mortgaged Property on such terms and for such period of time as Assignee may deem proper and, either with or without taking possession of the Mortgaged Property, in its own name, demand, sue for or otherwise collect and receive all Rents, including those past due and impaid with full power to make from time to time all alterations, renovations, repairs or replacements thereto or thereof as may seem proper to Assignee and may apply the Rents to the payment of the following in such order and proportion as Assignee in its sole discretion may determine, any law, custom or use to the contrary notwithstanding: (a) all expenses of managing and securing the Mortgaged

Property, including, without being limited thereto, the salaries, fees and wages of a managing agent and such other employees or agents as Assignee may does necessary or desirable and all expenses of operating and maintaining the Mortgaged Property, including, without being limited thereto, all taxes. charges, claims, assessments, water charges, sewer charges and any other liens, and premiums for all insurance which Assignee may deem necessary or desirable, and the cost of all alterations, renovations, repairs or replacements, and all expenses incident to taking and retaining possession of the Mortgaged Property, and (b) the Debt, together with all costs and attorneys' fees. The exercise by Assignee of the option granted it in this paragraph 2 and the collection of the Rents and the application thereof as herein provided shall not be considered a waiver of any default by Assignor under the Note, the Mortgage, the Leases, this Assignment or the Other Security Documents.

Assignce shall not be liable for any loss 3. sustained by Assignor resulting from Assigner P milure to let the Mortgaged Property after an Event of Default or from any other act or omission of Assigned in managing the Mortgaged Property after default unless such loss is caused by the willful misconduct and bad faith of Assignce. Assignee shall not be obligated to perform or discharge any obligation, duty or liability under the Leases or under or by reason of this Assignment and Assignor shall, and hereby agrees, to indomnify Assignce for, and to hold Assignce harmless from, any and all liability, loss or damage which may or might be incurred under the Leases or under or by reason of this Assignment and from any and all claims and demands whatsoever, including the defense of any such claims or demands which may be asserted against Assignee by reason of any alleged obligations and undertakings on its part to perform or discourge any of the terms. covenants or agreements contained in the Leases. Should Assignee incur any such liability, the amount thereof, including costs, expenses and reasonable attorneys' fees, shall be secured hereby and by the Mortgage and the Other Security Documents and Assignor shall reimburse Assigned therefor immediately upon demand and upon the failure of Assigner so to do Assignee may, a. its option, declare all sums secured hereby and the Mortgage and the Other Security Documents immediately due and payable and all such costs, expenses and attorneys' fees incurred by Assignee shall bear interest at the Note rate.
