4. Fire, Flood and Other Hazard Insurance. The interest rate will never increase or decrease by more than one percentage point (1.0%) on any single Change Date. The interest rate will never be more than five percentage points (5.0%) has been or lower than the initial interest rate.

(E) Calculation of Payment Change
