

SECOND LOAN MODIFICATION AGREEMENT AND AMENDMENT TO GRID NOTE, LOAN AGREEMENT, AND MORTGAGE AND ASSIGNMENT OF RENTS AND LEASES

This Loan Modification Agreement and Amendment To the Loan Agreement, Grid Note and Mortgage and Assignment of Rents is entered into this September 12, 1994, by and between The National Bank of Greece, S.A., CHICAGO BRANCI as Lender, Harris Trust and Savings Bank, as Trustee, under Trust Agreement dated 10/24/75 and known as Trust No. 36631, Chicago Future, Inc. and Pantells Kotsiopoulos as Borrower, effective August 25, 1994.

whereas, the parties have entered into a Loan Agreement by the terms of which Lender has extended a non-revolving Line of Credit in the amount of ONE NUMBED THIRTY THOUSAND (\$130,000.00) DOLLARS (Maximum) Secured by a Grid Note, Mortgage and Assignment of Rents dated August 25, 1993, the Mortgage and Assignment of Rents recorded on September 1, 1993, as document numbers 93696291/2; and as modified by Loan Modification Agreement dated December 23, 1993, and recorded on September , 1994 as Document Number 44 203 fact ; enabling the parties to borrow monies from the Lender; and

WHEREAS, the parties desire to (mend the minimum interest rate, increase the non-revolving line of credit by Eighty Thousand and 00/100 Dollars (\$80,000.00), and to extend the fine of Credit for an additional period of six (6) months to be secured by the same collateral as the original line of credit was secured by.

NOW THEREFORE, in consideration of the mutual covenants and agreements contained herein and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged by the parties, it is agreed as follows:

- 1. Amendment to the Loan Agreement, Grid Note, Mortgage and Assignment of Rents. The Loan Agreement, Grid Note and Mortgage and Assignment of Rents are hereby amended as follows:
 - (a) The amount of the Line of Credit wherever said amount is expressed in the Grid Note and Loan Agreement is hereby amended to provide: TWO HUNDRED TEN THOUSAND AND 00/100 (\$210,000.00) DOLLARS;
 - (b) In no event shall the charge in any month be less than 10.25%;
 - (c) The Maturity Date of the Grid Note and Loan Agreement are extended to February 25, 1995;

- (d) The Mortgage and Assignment of Rents which secure both the above mentioned Grid Note in the Modified amount of \$210,000.00, and the Installment Note in the amount of \$230,000.00, are hereby amended to provide: \$440,000.00 total principal amount;
- (e) To the extent the provisions of the Loan Agreement and the Grid Note are inconsistent, the provisions of the Grid Note shall control.

2. Continued Effectiveness of Documents

In all other respects the Grid Note, Loan Agreement, Mortgage and Assignment of Rants as modified December 23, 1993, shall remain unchanged and in full force and effect. In all respects the separate Installment Note as modified December 23, 1993 shall remain Coot County Clert's Office unchanged.
