Unit 29-B-1-2 in Hearthwood Farms Condominium, Phase III, as delineated on the survey of certain lots in Hearthwood Farms Subdivision, Unit 3 being a planned unit development in the Southeast 1/4 of Section 35, Township 41 North Range 9 East of the Third Principal Meridian in Cook County, Illinois which survey is attached as Exhibit "B" to the Declaration of Condominium recorded in the Office of the Recorder of Deeds of Cook County, Illinois as Document Number 88461155 and corrective amendment thereof recorded as Document 88505812 together with its undivided percentage interest in the common elements appurtenant to said unit as set forth in said Declaration

and commonly known as 320-B1 Newport Lane, Bartlett, Illinois
