## LIMITED IRREVOCABLE POWER OF ATTORNEY

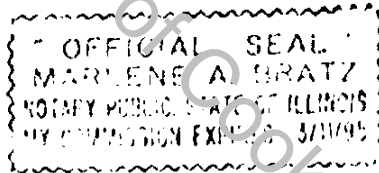
