1. That on April 11, 1994, the owners owned the following described land in the County of Cook, State of Illinois, to-wit:

That on April 11, 1994, while said owners still owned the above property, Contractor entered into a contract with the claimant to repair and plaster walls, door to openings and ceilings; install stude, lath & plaster and otherwise furnish patching and plastering services from on or about April 11, 1994 to June 30, 1994 on the above described property described at a price of THREE THOUSAND SEVEN HUNDRED FIFTY TWO DOLLARS [\$3,752.00] which price was to be paid upon completion. That on June 30, 1994 the claimant completed thereunder all work required by contract to be done.
- 3. The said owners are entitled to no credits leaving due, unpaid and owning to the claimant the sum of THREE THOUSAND SEVEN HUNDRES FIFTY TWO DOLLARS [\$3,752.00] which is still due and unpaid, plus attorneys fees and interest from June 30, 1994.
- 4. Claimant now claims a lien on the above described property and improvements on it, against the owners and all persons interested, and also plaims a lien on any amounts due from the owners to the contractor for THREE THOUSAND SEVEN HUNDRED FIFTY TWO DOLLARS [\$3,752.00], plus attorneys fees and interest, according to the statute.
