ADDITIONAL CONVENANTE, CONDITIONS AND PROVISIONS INFERIOR TO ON THE REVISION SEES OF THIS MORTGAGE AND INCORPORATED THEREIN BY REFERENCE

- 1. Mortgagors shall (1) promptly repair, restore or rebuild any buildings or improvements now or bereafter on the premises which may become diamaged or be destroyed; (2) keep said premises in good condition and repair, without waste, and free from mechanic's or other liens or claims for lien not expressly subordinated to the lien hereof; (3) pay when due any indebtedness which may be secured by a lien or charge on the premises superior to the lien hereof and upon request exhibit substances of the discharge of such prior lien to Mortgagee or to holder of the contract; (4) complete within a reasonable time may building or buildings now or at any time in process of streetion upon said premises, (b) comply with all requirements of law or numicipal ordinances with respect to the premises and the use thereof; (6) make no material alterations in said premises except as required by law or municipal ordinance.
- 2. Mortgagors shall pay before any pennity attaches all general taxes and shall pay special taxes, special assessments, water charges, sewer service charges, and other charges against the premises when due, and shall upon written request, furnish to Mortgages or to holders of the contract duplicate receipts therefor. To prevent default become Mortgagors shall pay in full under protest, in the manner provided by statute, any tax or assessment which Mortgagors may desire to contest.
- 3. Mortgagors shall keep all imildings and improvements now and bereafter situated on said premises insured against loss or damage by fire, lightning and windstorm under policies providing for payment by the insurance companies of moneys sufficient either to pay the cost of replacing or repairing the same or to pay in full the indebtedness secured hereby, all in companies satisfactory to the holders of the contract, under insurance policies payable, in case of loss or damage, to Mortgagee, such rights to be evidenced by the standard mortgage clause to be attached to each policy, and shall deliver all policies including additional and renewal policies to holder of the contract and in case of insurance about to expire, shall deliver renewal policies not less than ten days prior to the respective dates of expiration.
- 4. In case of default therein, Mortgagee or the holder of the contract may, but need not, make any payment or perform any act hereinbefore required of Mortgagors in any form and manner deemed expedient, and may, but need not, make full or partial payments of principal or interest on prior encumbrances, if any, and purchase, discharge, compromise or settle any tax lies or other prior lies on title or chim thereof, or redeem from any tax sale or forfeiture, affecting said premises or contest any tax or assessment. All moneys paid for any of these purposes herein authorized and all expenses paid or incurred in connection therewith, including attorneys fees, and or premises and the lies hereof, shall be so much additional indebtedness accured hereby and shall become immediately due and payable without notice. Inaction of Mortgagee or holders of the contract shall never be considered as a waiver of any right accruing to them on account of any default bereunder on the part of the Mortgagors.
- 5. The Mortgages or the holder of the contract hereby secured making any payment hereby authorized relating to taxes and assessments, may do so occarding to any hill, atatement or estimate procure (it) as the appropriate public office without impairy into the accuracy of such hill, statement or estimate or into the validity of any tax, assessment, sale, forfeiture, tax For a claim thereof.
- 6. Mortgagors shall pay each item of indebt closes berein mentioned, when due according to the terms hereof. At the option of the holder of the contract, and without notice to the Mortgagors, all unpaid indebtedness secured by the Mortgage shall notwithstanding anything in the contract or in this Mortgage to the contrary, become due and payable (a) in the case of clearly in making payment of any installment on the contract which default shall continue for 30 days, or (b) when default shall occur and continue for three days in the reformance of any other agreement of the Mortgagors herein contained.
- 7. When the indebtedness hereby secured shall become the whether by acceleration or otherwise, Mortgagee shall have the right to foreclose the lien hereof. In any suit to foreclose the lien hereof, there shall be allowed and included as additional indebtedness in the decree for sale all expenditures and expenses which may be paid or incurred by or on behalf of Mortgagee or holder of the contract for attorneys' fees, appraiser's fees, outlays for documentary and expense which may be stenographers' charges, publication costs and costs (which may it with a to items to be expended after entry of the decree) of procuring all such abstracts of title, title searches and examinations, guarantee policies. Torrens or rif to exe and similar data and assurances with respect to title as Mortgagee or holder of the contract may deem to be reasonably necessary either to prosecute such expenses of the nature in this paragraph mentioned shall become so much additional indebtedness secured hereby and immediately due and payable, when paid or four red by Mortgagee or holder of the contract in connection with (a) any proceeding, including probate and bankruptcy proceedings, to which either of them shall be a party, either as plaintiff, claimant or defendant, by reason of this Mortgage or any indebtedness hereby secured; or (b) preparations for the commencement of any or or ceding which might affect the premises or the security hereof whether or not actually commenced or (c) preparations for the defense of any threatened suit or proceeding which might affect the premises or the security hereof whether or not actually commenced.
- 8. The proceeds of any foreclosure sale of the premises shall be distributed and ar pile in the following order of priority: First, on account of all costs and expenses incident to the foreclosure proceedings, including all such items as are mentioned in the preceding paragraph hereof; second, all other items which under the terms hereof constitute secured indebtedness additional to that evidenced by the contract, third all other indebtedness, if any, remaining unpaid on the contract, fourth, any overplus to Mortgagors, their heirs, legal representatives or assigns as their rights may appear.
- 9. Upon, or at any time after the filing of a bill to forcelose this mortgage the court in which sich bill is filed may appoint a receiver of said premises. Such apointment may be made either before or after sale without notice, without regard to the solvency of the promises at the time of application for such receiver and without regard to the then value of the promises or whether the same shall be then occupied as such and the Mortgager hereunder may be applicated as such receiver. Such receiver shall have power to collect the rents, issues and profits of said promise in during the pendency of such foreclosure suit and, in case of a sale and a deficiency during the full statutory period of redemption, whether there be redemption in not, as well as during any further times when Mortgagors, except for the intervention of such receiver, would be entitled to collect such rents, issues and profits and all other powers which may be necessary or are usual in such cases for the protection, possession, control, management and operation of the premises during the photo of said period. The Court from time to time may authorize the receiver to apply the net income in his hands in payment in whole or in part of: (1) The of the bedness secured hereby, or by any decree foreclosing this Mortgage or any tax, special assessment or other lien which may be or become superior to the lien hereor or of the decree, provided such application is made prior to foreclosure sale; (2) the deficiency in case of a sale and deficiency.
