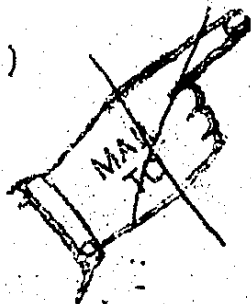

ORDINANCE NO. 930

## AN ORDINANCE VACATING AN ALLEY

WHEREAS, the Corporate Authorities have determined that the dedicated 20 foot alley, more fully described in Exhibit A, is no longer necessary; and

WHEREAS, the Village has located in said alley a sanitary sewer which can be maintained by the retention of a 15 foot easement.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Board of Trustees of the Village of Flossmoor, County of Cook, State of Illinois, that:

### Section 1.

The 20 foot wide alley described in Exhibit A is hereby vacated and the Village does hereby retain an easement for public utilities which easement shall be 15 feet on each side of center line of the hereinabove vacated alley.

### Section 2.

Ownership of the alley hereby vacated shall accrue to each of the abutting property owners along said alley to its centerline subject to the easement hereby retained.

### Section 3.

This Ordinance shall be in full force and effect from and after its passage and approval in accordance with law.


