

- 3.03. My Executor may in its discretion exercise the following powers, and any others that may be granted by law, in each case without court order:
- (a) To sell at public or private sale, to retain, to lease, to borrow money, and for that purpose to mortgage or to pledge, all or part of the real or personal property of my estate;
 - (b) To settle claims in favor of or against my estate;
- each, and for this purpose the determination of the executor as to the value of any property distributed in kind shall be conclusive;
- (d) To execute and deliver any deeds, contracts, mortgages, bills of sale, or other instruments necessary or desirable for the exercise of the Executor's powers and discretions;
- (e) To retain any person, firm, or bank as agent, and to delegate in writing to such agent any ministerial right, power, or discretion of the Executor, including the rights to sign and endorse checks and have access to any safe deposit box.

ARTICLE IV

- 4.01. If any beneficiary to whom any property becomes distributable hereunder dies within ninety (90) days of the date of my death, then the provisions of this Last Will and Testament shall take effect as if such beneficiary had predeceased me.
- 4.02 For the purposes of this Will, the term "descendants" shall only refer to those persons who (a) are born to a lawful marriage, or (b) are legitimized by a lawful marriage, or by other action, subsequent to birth, or (c) are adopted prior to attaining the age of eighteen (18) years.
