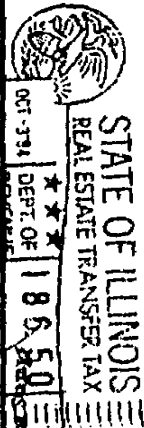

Legal Description attached to and made a part of that Trustee's Deeds dated August 16, 1994 between Chicago Title and Trust Company, as Trustee under a Trust Agreement dated August 6, 1994, Trust Number 1098688, as Grantor, and Michael E. That part of Lot 3 in the Villas of Palos Heights, Planned Unit Development, being a Subdivision of the North 671.53 feet (except the East 900 feet thereof and except the West 165 feet of the North 283 feet thereof and except that part taken for Highway) of the Northeast ¼ of the Northeast ¼ of Section 31, Township 37 North, Range 13, East of the Third Principal Meridian described as follows:
