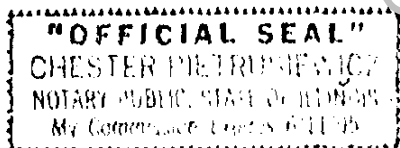
Willanita Johnson's second marriage was to Jaygold Johnson, they never had any children during the marriage or out of wedlock, nor did they adopt any children.
