THIS INDENTURE, made SEPTEMBER 29TH, 1994, between OAKBROOK BANK NOT PERSONALLY BUT AS TRUSTEE UNDER TRUST AGREEMENT DATED SEPTEMBER 7TH, 1989 AND KNOWN AS TRUST NO. 2191 herein referred to as "Mortgagors," and CHICAGO TITLE AND TRUST COMPANY, an Illinois corporation doing business in Chicago, Illinois, herein referred to as TRUSTEE, witnesseth:


