PARCEL ONE:

That part of the South West quarter of Section 34, Township 42 North, Range 9 East of the Third Principal Meridian described as follows: Commencing at a point in the West line of said Section 34, 176.1 feet North of the South West corner of said section; thence North on said section line 44.8 feet; thence East 416 feet; thence South 602.1 feet to the center line of the public highway known as Higgins Road; thence North Westerly along the center line of said road 444.8 feet to the place of beginning, excepting from said premises that part conveyed to the State of Illinois by highway by deed recorded as document 12089577; also excepting from said premises that part thereof described as follows: Beginning at the intersection of the East line of the West 416 feet of the West half of the South West quarter of said Section 34 with the Northerly line of the right of way of Higgins Road as conveyed to the State of Illinois by deed recorded as document 12089577; thence Westerly on the Northerly line of said right of way 264.99 feet; thence Northerly on a line drawn at right angles to the Northerly line of said right of way 192.17 feet; thence Easterly parallel with the Northerly line of said right of way 192.23 feet more or less to the East line of said West 416 feet; thence South on East line of said West 416 feet 203.22 feet more or less to the place of beginning; also excepting from said premises that part of said premises described as follows: Beginning at a point in the Northerly line of the right of way of Higgins Road as conveyed to the State of Illinois by deed recorded as document 12089577; 264.99 feet Westerly (as measured along said Northerly line of right of way line) of its intersection with the East line of the West 416 feet of said West half of the South West quarter; thence Northerly on a line drawn at right angles to said Northerly line of right of way 239.98 feet; thence Westerly on a line forming an angle of 72 degrees 49 minutes (from South to West with the last described line 257.43 feet) to a point in the West line of said West half of the South West quarter 175 feet North of its intersection with the Northerly line of Higgins Road; thence South on the West line of said West half of the South West quarter to the Northerly line of the right of way of Higgins Road; thence Easterly on the Northerly line of said right of way 179.63 feet more or less to the place of beginning, all in Cook County, Illinois.




