SUBORDINATION, ATTORNMENT AND NON-DISTURBANCE AGREEMENT

This Subordination, (ttomment and Non-Disturbance Agreement (the "Agreement") is made and entered into as of the <u>Sat</u> day of <u>OCT</u>, 1884, by and among Honey Baked Ham Co., an Illinois Corporation ("Tenant"), American National Bank & Trust Company of Chicago, as Trustee under Trust Agreement dated December 1, 1991, and known as Trust No. 114854-06 (hereafter referred to as either "Landlord", or "Borrower") and The Prudential insurance Company of America, a New Jersey corporation (hereafter referred to as "Lender").

WHEREAS, Lender has made a loan (the "Loan") to Borrower evidenced by a note (the "Note") secured by a mortgage (the "Mortgage", dated 9-25 9y and recorded among the records of the office of the Cook County, Illinois Recorder of Deeds constituting a first lien upon the land described in Exhibit "A" attached needs and made a part hereof and the improvements thereon, as well as all of Landlord's right, title interest, estate and claim now owned or hereafter acquired in, to or relating to the items described in (i) through (ix) in the recitals of the Mortgage (collectively, the "Property") and

WHEREAS, Landlard and Tenant have entered into a certrin lease dated September 9, 1994, which lease provides for the direct payment of rents from Tenant to Landlard for the use and occupancy of the Honey Baked Ham store building located at Broadview Village Square, Broadview, Illinois, (the "Premises") by Tenant, as more fully set forth in the lease (hereafter, the lease and all present and future amendments and modifications thereto, and extensions thereof, shall be referred to as the "Lease"); and

WHEREAS, Lender wishes to obtain from Tenant certain assurances that Tenant will attorn to the purchaser at a foreclosure sale in the event of a foreclosure or to the holder of the Note and Mortgage in the event of such holder's exercise of its rights under the Note and Mortgage; and

WHEREAS, Tenant wishes to obtain from Lender certain assurances that so long as Tenant is not in default of Tenant's obligations to Landlord under the Lease, that Tenant

shall not be disturbed in its peaceful possession of the Premises as a result of actions taken by Lender pursuant to its rights under the Mortgage; and

WHEREAS, Tenant and Lender are both willing to provide such assurances to each other upon and subject to the terms and conditions of this Agreement.

NOW. THEREFORE, in consideration of the above, the mutual promises hereinafter set forth, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto mutually agree as follows:

- 1. Subordination and Attornment. The Lease and all of the rights of Tanant thereunder shall be and are hereby declared to be and at all times hereafter shall be and remain subject and subordinate in all respects to the Mortgage and to all renewals, modifications, consolidations, replacements and extensions thereof and all of the rights of the Lender the rounder and all other documents securing the Note. Notwithstanding such subordination. Tenant hereby agrees that the Lease shall not terminate in the event of a foreclosure of the Mortgage whether judicial or nonjudicial or any other proceedings brought to enforce the Mortgage or by deed in lieu of foreclosure and Tenant further agrees to attorn to and to recognize Lender (as mortgages in possession or otherwise), or the purchaser at such foreclosure sale, as Tenant's landlord for the balance of the term of the Lease, in accordance with the terms and provisions thereof, but subject, nevertheless, to the provisions of this Agreement, which Agreement shall be controlling in the event of any conflict.
- Estoppel. Landlord and Tahant hereby agree that the Lease is valid, enforceable and in full force and effect, that as of the date hereof there are no defaults by Landlord or Tenant, that there are no set offs or counterclaims by Tenant to the payment of rant due under the Lease, that all conditions to the effectiveness or continuing effectiveness of the Lease required to be satisfied also the date hereof have been statisfied, that the Lease is a complete statement of the agreement of Tenant and Landlord with respect to the Premises, and that the Lease has not been modified or amended except as set forth below:
- Tenant's Representations and Warranties. Tenant hereby represents and warrants to Lender that it has not subordinated the Lease or any of its rights thereunder to any lien or mortgage other than the Mortgage and that it will not subordingly the Lease or its rights thereunder to any lien or mortgage without the prior written consent of Lender, or in accordance with Section 13.1.J. of the Lease.
- 4. Lender's Notice and Cure Rights. Tenant agrees with Lender that, from and after the date hereof until payment in full of the indebtedness under the Note, Tenant will not terminate the Lease nor discontinue or abate the rent as a result of a default by Landlord under the Lease, without first giving the Lender notice and an opportunity, at Lender's option, to cure such default, provided such default is capable of being cured by Lender. In the event such default by Landlord under the Lease is not susceptible to cure by the Lender, Tenant may, at its option, exercise all its rights under the Lease (including, without limitation, the right to terminate the Lease or discontinue or abate rent), Notwithstanding the foregoing, Tenant shall not terminate the Lease nor discontinue or abate rent as a result of a default by Landlord under the Lease if (a) the Lender is diligently in the process of foreclosing on the Property and (b) the continuation of such default by

Landlord under the Lease during the time period required for foreglosure does not (i) unreasonably interfere with the Tenant's use and enjoyment of the Premises under the terms of the Lease nor (ii) impose any additional obligations on the Tenant not contained in the Lease. Tenant also agrees that, at the request of Lender the rent payments due under the Lease shall be paid directly to Lender and any such payments to the Lender shall be credited against the rent due under the Lease as if made to the Landlord. Tenant agrees that prior to exercising any of its rights and remedies under the Lease in the event of any default by Landlord thereunder, including any rights of offset, defense or self help provisions contained in the Lease, Tenant shall give written notice to Lender of the occurrence of default by Landlord and Landlord's failure to cure such default pursuant to the terms of the Lease, specifying, with reasonable clarity, the events constituting such defaut, and shall give Lender thirty (30) calendar days after the date of receipt of such notice to undertake to cure such default, provided however, such thirty (30) day period shall be extended provided that Lender is proceeding diligently to cure such default.

5. Non Disturbance. So long as Tenant is not in default under the Lease beyond any notice and cure period provided in the Lease, then Lender agrees with Tenant that in the event the interest of Landlord is acquired by Lander, or Lander acquires title to the Property or comes its possession of said Property by reason of foreclosure or enforcement of the Mortogogo or the Note, or by a conveyance in lieu thereof, or by any other means, Tenant's passession of the Premises and Tenant's rights, privileges and obligations under the Lease Shall-not be disturbed, diminished or interfered with by Lender or any party claiming through Lander during the term of the Lease, including any extensions thereof permitted to Tenant, and the Lease shall continue in full force and effect and shall not be terminated except in accordance with the terms of the Lease. In the event Tenant defaults under the Lease or this Agreement, the obligations of Lender hereunder shall, at Lender's election, become null and void and Lender may proceed to extinguish the Lease and all of Tenant's rights and interests in and to the Premises through forecipse of the Mortgage.

immediately upon the acquisition by Lender of postession or title to the Property by reason of foreclosure or enforcement of the Mortgage or the Note, or by a conveyance in lieu thereof, or as a result of any other means. Tenant agrees to be bound to Lender under all of the terms, covenants, and conditions of the Lease for the balance of the term thereof, including any extensions thereof permitted to Tenant, with the same force and effect as if Lender were the landlord under the Lense, and Tenant does hereby according Lender as its landlord, said attomment to be effective and self-operative without the execution of any other instruments on the part of either party hereto.

Lender further agrees that if it obtains possession or title to the Property during the Lease term, Lender shall be bound to Tenant under all of the terms, covenants, and conditions of the Lease and Tenant shall, from and after the occurrence of the events set forth above, have the same remedies that Tenant might have had under the Lease against Landlord; provided, however, that Lender shall not be:

- a. liable to Tenant for damages for any act or omissions of Landlord or any prior landlord occurring prior to Lender obtaining possession or title to the Property: or
- subject to any claims (but not including any claims asserted as counterclaims) which Tenant might have against Landlord or against any

prior landlord which arise prior to the date Lender obtains possession or title to the Property; or

- c. bound by any rent or additional rent or deposit, rental security or any other sums which Tenant may have paid to Landlord or any other landlord more than thirty (30) days in advance; or
- d. bound by any amendment or modification of the Lease made without Lender's prior written consent; or
- e. bound to the Tenant subsequent to the date upon which the Lender transfers its interest in the Property to any third party, provided, however that Lender shall be liable for any claims that arose during the period Lender owned the Property: or
- Itable for the payment of any leasing commissions or other expenses for which Landlord or any prior landlord incurred the obligation to pay, provided. however, that Lender shall not be relieved of the liability to pay CB Commercial Real Estate Group, Inc. described in Section 28.14 of the Lease; or
 - g. bound or illibit to Tenant under any oral or written notice given by Tenant to Landlord or any prior landlord that was not also given to Lender; or
 - bound under alty provision of the Lease which may give rise to h. liabilities, duties or responsibilities of Lender for any matters relating to hazardous materials or the environment, except to the extent that such liabilities, duties or responsibilities are caused by acts or omissions of Lender or any prior landlord under the Lease.
- 5. Obligations of Succeeding Owner. Tenant hereby agrees that any entity or person which at any time hereafter becomes the Landlerd under the Lease, including, without limitation. Lender, as a result of Lender's exercise of its rights under the Mortgage, or a purchaser from Lender, shall be liable only for the performance of the obligations of the Landlord under the Lease which arise and accrue during the period of such entity's or person's ownership of the Property: provided, however, that Tenant simil except as set forth in Sections 5(a) and 5(b) above, retain all rights of offset, defenses, counterclaims and rights to terminate that arose prior to such entity or person acquiring the Property.
- Notices. All notices or other written communications required or permitted to be given pursuant to this Agreement shall be in writing, and shall be deemed to have been properly given (I) upon delivery, if delivered in person or by facsimile transmission with receipt acknowledged, (ii) one business day after having been deposited for overnight delivery with any reputable overnight courier service, or (iii) three business days after having been deposited in any post office or mail depository regularly maintained by the U.S. Postal Service and sent by repistered or certified mail, postage prepaid, addressed as follows:

- 8. Miscellaneous. This Agreement may not be amended or modified in any manner other than by an agreement in writing, storied by the parties hereto or their respective successors in interest, and this Agreement shell be binding upon and inure to the benefit of the parties hereto and their respective successors and assigns. The words "foreclosure" to and "foreclosure sale" as used herein shall be deemed to include the acquisition of A Landlord's estate in the Property by voluntary deed, assignment or other conveyance or transfer in lieu of foreclosure; and the word "Lender Soull include the Lender herein the specifically named and any of its successors and assigns, including anyone who shall have succeeded to Landlord's interest in the Property or acquired possession thereof by, 🖫 through or under foreclosure of the Mortgage, or by any other mariner of enforcement of the Mortgage, or the Note or other obligation secured thereby.
- 9. Conflicts with Lease. This Agreement shall supersede, as between Tenant and Lender, all of the terms and provisions of the Lease which are inconsistant with this Agreement, but shall not affect any obligations or liabilities of Borrower, as landlord, under the Lease.
- 10. Governing Law: Venue. This Agreement shall be construed in accordance with the laws of the State of Illinois and any Iltigation arising out of this Agreement shall be brought in the courts of the State of Illinois or in the courts of the United States for the Northern District of the State of Illinois and all parties hereto consent to the venue of such courts.
- 11. Effect of Agreement. Landlord joins in the execution and delivery of this Agreement for the purpose of evidencing its consent to the terms and provisions hereof, and as between Landlord and Tenant, nothing herein contained shall be deemed to alter or

modify the Lease. As between Lender and Landlord, nothing contained herein shall be deemed to alter or modify the terms and conditions of the Note, the Mortgage, or any other document or agreement regarding the mortgage loan made by Lender to Borrower.

- 12. Construction. All capitalized terms not otherwise defined herein shall have the meanings ascribed to such terms in the Mortgage.
- 13. WAIVER OF TRIAL BY JURY: ALL PARTIES HERETO HEREBY WAIVE, TO THE FULLEST EXTENT PERMITTED BY LAW, THE RIGHT TO TRIAL BY JURY IN ANY ACTION, PROCEEDING OR COUNTERCLAIM, WHETHER IN CONTRACT, TORT OR OTHERWISE, RELATING DIRECTLY OR INDIRECTLY TO THE LOAN, THE LOAN DCCVMENTS, INCLUDING, WITHOUT LIMITATION, THIS AGREEMENT, OR ANY ACTS COOK COUNTY CLERK'S OFFICE OR CHISSIONS OF LENDER ITS OFFICERS, EMPLOYEES, DIRECTORS OR AGENTS IN COUNECTION THEREWITH.
