OF
JLE, INC.

I, the undersigned, acting as incorporator of the Corporation under the Illinois Business Corporation Act, adopt the following Articles of Incorporation for such Corporation:

ARTICLE I
CORPORATE NAME

The name of the Corporation is JLE, INC.
