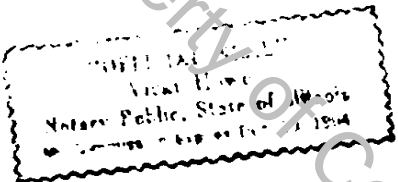

### PARCEL 1:
